Subject	<i>FHA Catalyst</i> : Claims Module - Single Family Forward Supplemental Claims Digital Submission
Purpose	This Mortgagee Letter (ML) announces a new supplemental claim submission method involving the Federal Housing Administration's (FHA) implementation of <i>FHA Catalyst</i> , a new web-based platform, and provides information for mortgagees to prepare and submit supplemental claim packages electronically through FHA's new platform.
Effective Date	Effective immediately, the <i>FHA Catalyst</i> platform is available for all mortgagees and/or their authorized party to submit supplemental claims electronically. Submission of supplemental claim packages through the platform is optional.
Public Feedback	HUD welcomes feedback from interested parties for a period of 30 calendar days from the date of issuance. To provide feedback on this policy document, please send feedback to the FHA Resource Center at <u>answers@hud.gov</u> . HUD will consider the feedback in determining the need for future updates.

Affected Programs	This guidance applies to the FHA Title II Single Family forward mortgage program.
Platform Overview and Functionality	FHA approved mortgagees and/or their authorized users may use <i>FHA Catalyst</i> to electronically transmit supplemental claim packages, which include information found on Form HUD-27011, Single Family Application for Insurance Benefits, and any relevant supporting documentation, in lieu of mailing supplemental claim submissions to HUD and uploading to P260.
	Mortgagees remain responsible for proper submission of supplemental claims and ensuring they meet FHA's requirements and standards for such submissions. By transmitting a supplemental claim package, the mortgagee and/or their authorized party is certifying that the statements and information submitted are true and correct.

	Digital Submission process will be incorporated into the <u>4000.1 FHA</u> <u>Single Family Housing Policy Handbook</u> at a future date.
