## SUBJECT: HUD's Proposed Federal Flood Risk Management Standard Rule

Dear Tribal Leader:

On August 6, 2021, the U.S. Department of Housing and Urban Development (HUD) completed Tribal consultation on the proposed Federal Flood Risk Management Standard Rule (FFRMS). HUD is now seeking public comment on the recently published proposed rule that intends to protect communities and taxpayer investments from current and future flooding. Information on how and where to submit comments can be found in the Notice of Proposed Rulemaking <u>here</u>. The public comment period ends on May 23, 2023.

## Background

HUD's proposed rule addresses requirements of both Executive Order (E.O.) 13690, Establishing a Federal Flood Risk Management Standard and a Process for Further Soliciting and Considering Stakeholder Input and EO 14030, Climate-Related Financial Risk.

Key elements of HUD's proposed rule include:

- establishing a Climate Informed Science Approach (CISA) as the preferred method to determine the FFRMS Floodplain,
- expanding the floodplain of concern (currently 100-year floodplain) **both** vertically and horizontally,
- revising HUD's Minimum Property Standards for one-to-four unit single family housing under the FHA mortgage insurance program and revising minimum elevation of structure requirements above the floodplain for new and substantially improved low-rent public housing program recipients; and
- expanding applicability of floodplain determinations to include **both current and projected flooding risks** under the longstanding floodplain management 8-step decision making process.

Additionally, we will be hosting live information and listening sessions where interested members of the public and stakeholder groups may provide oral or written comments on May 2<sup>nd</sup> and May 15<sup>th</sup>. Each session will be hosted from 3:00-4:30 PM EST. Registration information for the sessions can be found at the links below.
