The **Eastern Woodlands Office** (EWONAP) serves 66 Tribes within 16 states and 6 HUD regions. EWONAP administers over \$90 million in IHBG funds, over \$60 million in Section 184 Native American Home Mortgages, and approximately \$5 million in ICDBG funds in its region annually.

GREETINGS FROM ADMINISTRATOR

Greetings,

End of the Fiscal Year. September 30th marks the end of the Federal Fiscal year. What that means for Grantees is that you must sometimes wait for your IHBG funds to be placed in your eLOCCS accounts until the money arrives from the appropriators (Congress) to Treasury, then to HUD and finally to PIH and your accounts. This year is no different, except that there are the usual differences between parties in Congress and so a Continuing Resolution or CR will be required by October 1st to keep non-

critical Federal offices open. For some of you who might be new to this process, a government shutdown includes the Office of Native American Programs [ONAP] as non-essential.

The **Indian Community Development Block Grant [ICDBG] NOFO** has been published. The application due date is **October 25, 2021**. ONAP's Indian Community Block Grant Program is open to Federally Recognized Tribes and their designated Agencies to apply in a competitive Grant process. The five State recognized Tribes funded under the Indian Housing Block Grant [IHBG] program are NOT eligible for this grant. One emphasis in the Grantee training held on September 22 & 23d was that grantees who timely file their paperwork such as Audits, APRs and Standard Form 425 quarterly reports are rewarded in the rating and ranking process. A simple thing like a late filed audit can disqualify a Tribe from receiving a Grant. That is why it is important to meet those filing deadlines and stay in contact with Audit firms to insure they file their audit (for Grantees receiving over \$750,000 annually) on time with the Federal Audit Clearinghouse. For your ICDBG application consider filing a bit early at Grants.gov to avoid a possible logjam or system crash as potentially hundreds of applications are coming in during the same period. The minimum amount that can be applied for is \$500,000 with the maximum varies by region but is \$700,000 for the Eastern Woodlands ONAP. Applications for more than the ceiling will not be considered. The total amount available for EWONAP is \$6,030,948.00. If each applicant applies for the maximum, there is room for 8.6 grants in Eastern Woodlands.

The next round of Indian Housing Plans [IHP] are due on or before October 17th, which is 75 days before programs with a fiscal year ending on December 31, 2021. Make sure to have any Tribal resolutions approving the IHP passed before its submission. This will expedite its approval. Waivers may be requested but must meet the standard of factors beyond the control of the applicant. Good planning means that approval by the Board of Commissioners or Tribal Council is in the control of the applicant, so a waiver must show something beyond that. About a third of EWONAP grantees are due on October 17th and some have already been submitted.

Columbus Day a/k/a Indigenous Day (in a growing number of jurisdictions) is October 11th. This is a Federal Holiday, and our offices will be closed. We will be open for business on Tuesday October 12, 2021.

- **ICDBG-ARP.** There is still time to apply for ICDBG-ARP.
- ONAP is accepting ICDBG-ARP applications on a first come, first serve basis.
- The deadline for Phase II is October 18th at 6:00PM ET.
- **IHBG Comp training** has been announced and will take place on October 27th and 28th.
- **Tribal Consultation.** ONAP is currently conducting Tribal consultation on the draft Coordinated Environmental Review Implementation Plan.
- All are encourage to read the draft implementation plan and participate in the next Tribal consultation session which will be held next week on October 7, 2021.

SPOTLIGHT ON TRIBE:

HOULTON BAND OF MALISEET INDIANS

The Houlton Band of Maliseet Indians (HBMI) in Houlton, Maine, utilized ICDBG Imminent COVID-19 funds to respond and prepare for the COVID-19 pandemic by retrofitting and expanding an existing facility within the Maliseet Village for a food pantry. HBMI retrofitted the entire first floor to accommodate the food pantry and expanded it an additional 720 sq. feet to incorporate a walk-in cooler and freezer. The second level was rehabbed to add additional office space for staff that were initially located on the first level. The project was a comprehensive effort to maximize the capacity of the Center's ability to provide services to the community. While the grant did not require matching funds, the tribe contributed funds from other COVID funding to purchase and install a cooler, freezer and generator. The design allows plenty of space for social distancing for staff and easy accessibility for the community to drive through for pick-up. HBMI also created an agricultural program during the pandemic to provide fresh fruits and vegetables to the community to address food insecurity as part of a Food Sovereignty initiative, and will be distributed and stored at the Food Pantry. HBMI encourages community participation with design and tries to incorporate cultural components created by tribal members. Tribal member, Heidi Kelley designed the signs and Chris Phillips created an ash basket weave wall accent for the waiting area. The Tribe has stated that ICDBG funding has made a huge impact on their community for decades, strengthening its capacity to provide services for all ages.

INDIAN COUNTRY NEWS

NOTICE OF FUNDING OPPORTUNITY (NOFO) FY2021 INDIAN HOUSING BLOCK GRANT COMPETITIVE PROGRAM NOFO

- HUD has published the FY21 Indian Housing Block Grant (IHBG) Competitive Program NOFO which provides \$95 million for affordable housing in Tribal communities.
- This NOFO gives priority for new or unfunded applicants and prioritizes applications that propose funding new housing construction projects, housing rehabilitation, acquisition of existing housing units that increase affordable housing stock.

APPLICATIONS FOR FY 2021 IHBG COMPETITIVE PROGRAM NOFO ARE DUE TO HUD ON DECEMBER 1, 2021

FY2021 INDIAN COMMUNITY DEVELOPMENT BLOCK GRANT NOFO

- HUD published the FY21 ICDBG NOFO.
 - This NOFO provides over \$76 million to develop community facilities, carry out public works projects, develop infrastructure, and provide economic development assistance.
 - Our Office of Grants Management will provide a national training date for this NOFO very soon.
- Applications for the FY21 ICDBG Program NOFO are due to HUD on October 25, 2021.

ICDBG-ARP

- HUD published the ICDBG-ARP Implementation Notice.
 - The ICDBG-ARP program will invest \$280 million in Tribal communities through the development of infrastructure and other projects related to the fight against COVID-19.
 - Our regional offices have notified Phase 1 grantees of their eligibility to apply and have provided trainings.
 - Phase II began on September 3rd and applications will be accepted on a first come, first served basis.

FY2021 CONTINUUM OF CARE NOFO

- I know that many of you have inquired about the CoC program.
 - Last week, HUD's Office of Community Planning and Development published the FY21 Continuum of Care NOFO
 - For the FY 2021 competition, Tribes and TDHEs will be eligible to apply for projects through existing CoCs only.
- Deadline for this opportunity is November 16, 2021.

CHILD TAX CREDIT

Continuing through December 2021, the new [Child Tax Credit](#) in the American Rescue Plan (ARP) Act provides monthly benefits of \$250 per child between ages 6-17 and \$300 per child under age 6.

MORTGAGE FORBEARANCE

EMERGENCY BROADBAND BENEFIT

The Emergency Broadband Benefit Program is a [Federal Communications Commission \(FCC\) program](#) that provides a temporary discount on monthly broadband bills for qualifying low-income households. If your household is [eligible](#), you can receive:

- Up to a \$50/month discount on your broadband service and associated equipment rentals
- Up to a \$75/month discount if your household is on qualifying Tribal lands
- A one-time discount of up to \$100 for a laptop, tablet, or desktop computer (with a co-payment of more than \$10 but less than \$50)

EMERGENCY RENTAL ASSISTANCE

In response to the impacts of the COVID-19 pandemic, the Emergency Rental Assistance (ERA)



program makes funding available to states, U.S. territories, local governments, Indian tribes or Tribally

Designated Housing Entities, and the Department of Hawaiian Home Lands to assist households that are unable to pay rent or utilities. It announced the opportunity to apply for approximately \$95 million in competitive grants to eligible Indian tribes and tribally designated housing entities (TDHEs). This program provides competitive grant funding to Tribes and TDHEs to carry out affordable housing activities for the benefit of low-income Native American families. In accordance with the FY21 Consolidated Appropriations Act, HUD will prioritize grant applications that spur housing construction and rehabilitation.</p>

The Section 184 Indian Home Loan Guarantee Program is a home mortgage specifically



designed for American Indian and Alaska Native families, Alaska Villages, Tribes, or Tribally Designated Housing Entities. Section 184 loans can be used both on and off native lands for new construction, rehab, the purchase of an existing home, or for refinancing.

Section 184 is synonymous with home ownership in Indian Country. As of March 2016, the Section 184 program has guaranteed over 33,728 loans, which represents over \$5.4 billion dollars in guaranteed funds.

Within the Eastern Woodlands region, over 3,938 loans have been made bringing \$565 million in private capital directly to Tribal Members. Tribes and TDHEs can also use Section 184 loans to achieve their housing development goals. Some benefits include:

- Low residential mortgage interest rates
- Lower monthly fees than standard PMI
- One time loan guarantee fee (1.5%)
- May utilize up to 15% of loan funds for site infrastructure costs
- Low down payment
- No household income restrictions
- Buy, Rehab, Refi or Build
- Finance up to 20 units at a time.

HUD ONAP Title VI Loan Guarantee Program- Title

VI loans enable Indian Housing Block Grant recipients to leverage up to 5 times their IHBG 'Need' funding to finance affordable housing development by pledging future IHBG grant funds as security for repayment of the loan. A private lender provides the financing and HUD provides the guarantee to the lender. To visit the Title VI website, [click here](#). ONAP's Office of Loan Guarantee has advised that Title VI loans are limited this fiscal year, so the first funded loans will go to applicants whose loan package is the most complete first. MOWA Choctaw HA	Construction of 12-15 lease to purchase homes.
Iswa Development Corp.	Construction of 65 Single Family homes, 25 cottages and 30 multifamily units.
Aroostook Band of Micmac	Construction of 17 units in two communities.
Pleasant Point Passamaquoddy	Construction funding for 28 rental homes and the community center, leveraging LIHTCs.
Pleasant Point Passamaquoddy	Construction of 9 units of low income rentals. Leveraged USDA, ARRA and private grants.
White Earth Reservation HA	Refinancing of 3 different loans used to fund equity in 2 LIHTC projects.
Lac Courte Oreilles HA	Construction of 20 multifamily units.
Ho-Chunk Housing & CDA	Construction of 36 units of multifamily housing, including 4 units of transitional housing.
Red Lake Reservation HA	Construction of 45 units of homeownership units.
Lumbee Tribe	Construction of 50 unit LIHTC project for Elders.
