Systems Not in Compliance with Federal Financial Management Systems Requirements

The following 18 HUD Financial Management Systems are not in compliance with federal financial management systems requirements. One of the 18 non-compliant systems is considered immaterial in its nonconformance to requirements because the system was scheduled to be and was discontinued in October 1999.

HUD reduced the number of non-compliant systems from 98 at the end of fiscal 1992 to 18 at the end of fiscal 1999. The reduction in non-conforming systems is attributable to HUD's ongoing effort to implement a single integrated financial management system which has consolidated systems/ system functions and provided the required processes to comply with federal financial management requirements, as well as replacing legacy systems with compliant systems. Five of the non-conforming systems are scheduled to be terminated in fiscal 2000, with another three in fiscal 2001.
