## **PERFORMANCE WORK STATEMENT**

### **BACKGROUND**

The Dept of Housing and Urban Development manages a portfolio of FHA insured and non FHA insured multifamily housing properties. As part of its asset management responsibilities it is required to ensure that reserve and replacement funds are used to maintain properties sufficiently. The HUD Real Estate Assessment Center (REAC) evaluates all properties with a yearly physical and financial assessment and recommends corrective actions that may include required repair and renovations to insure that properties offer safe and sanitary housing for residents and also preserves HUD's financial commitment to such properties.

### **OBJECTIVE**

The objective of this effort is issue task orders to have inspectors monitor the progress of such repairs and renovations. The reports outlined below specify some HUD forms but the narrative and interpretation of issues related to each inspection is the responsibility of the contractor. The reports should provide the Government Technical Representative (GTR) and the asset manager with sufficient information to determine that progress is being made in accordance with building codes and practices and any HUD specific issues.

### **PERFORMANCE REQUIREMENTS**

#### **Frequency of Inspections**

Inspections may be weekly, bi weekly or monthly as determined in each task order

#### **Items to be inspected/reported:**

1. Conduct inspections of ongoing rehab/renovation work as necessary to meet project requirements Samples of work to be included in task order are:

#### **BUILDING EXTERIORS:**

Roof replacements (shingle and composition)  
 Exterior walls (vinyl, wood shingle, cement, brick & mortar, composition panels, concrete)  
 Painting/staining

 (All structures included possible demolition of existing, excavation/foundation thru complete structure ready for occupancy)

NOTE: All new structures will require after completion, a follow-up nine-month inspection to record possible deficiencies.

2. Ensure that all work complies with local, state, federal codes and regulations
3. Ensure that all work is performed in accordance with applicable plans and specifications
4. Ensure that all work is performed in a safe manner
5. Meet with all applicable on-site personnel to review project status and obtain daily work logs
6. Review all contractor's payment requisitions and make appropriate recommendations
7. Report any and all non compliances, delays, or disputes relating to the project
8. Report any and all resident or management concerns relating to the project
9. Determine "scheduled" progress vs. "actual" progress
10. Attend construction meetings at frequency specified in the task order
11. Provide a minimum of 3 progress photos per inspection

**Responsibilities of Contractor:**

1. Inspections will be required to furnish their own transportation, and equipment
2. Contractor shall submit his/her report electronically on HUD 5379 (sample form will be provided in MS Word fillable version)

The trip report shall include, as a minimum, the following information.

Construction activity on the day on visit

Construction completed to date;

Physically inspect randomly all systems installed noting deficiencies if/as found,

All deficiencies MUST be noted on report (included the building code violation as applicable).

Any deficiencies noted MUST be discussed with project supt. (clerk of works) on the day of the visit.

All project's that require progress payment requisition meetings, must be attended by the inspector.

Inspector must note in trip report his/her recommendation for payment.

Inspector MUST included the following information requested in the HUD Representative's Trip Report:

**Evaluation: Details – Concerning:**

- Contractor's organization, operation and supervision
- Administration of Construction Contract
- Architect's supervision and services
- Special circumstances, occupancy, delays, claims, disputes, etc.
- Non-compliance in the work
- Payments to the contractor, Labor and EEO Provisions

3. Contractor shall submit reports in accordance with the schedule provided in each task order.

However, in general, reports are submitted to GTR as two separate reports together, 5 calendar days after the second report. Invoices should accompany the delivery of the reports.

4. Contractor shall maintain one set of drawings, specifications, General Contractor's weekly status reports meeting notes and all correspondence from the HUD Field Office
5. Upon completion of the task order, the contractor shall submit all issued documents.
6. Contractor shall prepare payment vouchers (sample form will be provided in MS work compatible format) and submit to GTR.
7. Inspector must have the following communication equipment;

(f) The Contractor is responsible for the accuracy and completeness of the data within the CCR database, and for any liability resulting from the Government’s reliance on inaccurate or incomplete data. To remain registered in the CCR database after the initial registration, the Contractor is required to review and update on an annual basis from the date of initial registration or subsequent updates its information in the CCR database to ensure it is

current, accurate and complete. Updating information in the CCR does not alter the terms and conditions of this contract and is not a substitute for a properly executed contractual document.

(d) *Inspection/Acceptance*. The Contractor shall tender for acceptance only those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. The Government must exercise its postacceptance rights --

(1) Within a reasonable period of time after the defect was discovered or should have been discovered; and

(2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(e) *Excusable delays*. The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence, such as acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify

(f) *Termination for the Government's convenience.* The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges that the Contractor can demonstrate to the satisfaction of the Government, using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred that reasonably could have been avoided.

(g) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(h) *Warranty.* The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.
