**Executive Summary of the Annual PHA Plan**

[24 CFR Part 903.7 9 (r)]

The housing Authority of the City of Van Buren, Arkansas, has taken the new Quality of Housing and Work Responsibility Act of 1998 as an exceptional event requiring an exceptional response. For the first time in sixty years, Congress has seen fit to make substantial alterations to the Housing Act of 1937.

In order to assure that the Van Buren Housing Authority (VBHA) makes a proper response to this new planning requirement in section 511 of the QHWRA, the VBHA appealed to Arkansas NAHRO for assistance. That organization obtained professional technical assistance and training for Arkansas member PHA interested in joining together to approach the QHWRA Agency Plan requirement. As a result of that effort, and after discussions with Arkansas NAHRO, with other housing agencies, and after reviewing material supplied by the Little Rock HUD field office, the VBHA believes it has adopted a planning approach that meets both the needs of the Authority's residents and the new federal review standards.

In preparing its plan, the VBHA recognized the need to explore possibilities and plan for the improvement of its operations, and more importantly, to modernize for successful functioning and achievements in the twenty-first century.

The VBHA has developed a plan that is consistent with HUD's stated mission and goals. It has also developed a plan that provides for measurable standards against which plan objectives can be measured. As a step towards its own improved management, the VBHA has keyed these standards to the requirements in the Public Housing Management Assessment Program.

The VBHA has established its fundamental goals. These are to assure good quality housing for its residents, to encourage resident responsibility for their living space, to provide self-sufficiency opportunities for residents, to assure equal opportunity for its housing, and to provide current, sound management policies and practices to its operations.

Although the VBHA has made a streamlined submission, it is mindful that the requirements for a shortened submission do not exclude it from having to meet all requirements of the QHWRA; therefore,

it has made clear where and when items not submitted with its plan may be viewed by the public. The VBHA met with its residents to gain their assistance first in performing a needs assessment for Authority operations, then for additional input on developing parts of the Annual Plan. The VBHA has documented those meetings, and it has shown how it will address resident suggestions for its plan.

The VBHA has a small staff, This has made it difficult for the Authority to amend all of its policies, practices, lease, etc. to conform to the requirements QHWRA in time for this submission. The Authority is aware that it needs to make changes to these items. It has made that a primary operational goal. The Authority is working hard to comply with the details of the new law as quickly as it can, consistent with its limited resources.

**In a cooperative agreement with the Van Buren Police Department, the Van Buren Buren Housing Authority has developed a strategy to promote the Housing Authority as a Drug Free & Enhanced Sentencing Neighborhood. The Van Buren Housing Authority consists of 200 units of which 100 family units located at Jesse Turner Terrace and 25 family units in Royal Oaks subdivision being the targeted areas for Public Housing Drug Elimination Program Assistance.**

**The strategy for utilizing PHDEP Funding is to improve the quality of life for the Van Buren Housing Authority is to aggressively project a “Tough on Crime” neighborhood.**

**The plan includes:**

- I. Changing names of Jesse Turner Terrace. This development has had a negative reputation for a number of years. A new name, heavily promoted will indicate a new management and a new way of doing business.**
- II. Install signs at each entrance into Jesse Turner (3 signs) and Royal Oaks (2 signs) informing the public that these neighborhoods are “Enhanced Sentencing Area” wherein a Judge can double the sentence on criminals. This would warn potential criminals to reevaluate these locations for their activities.**
- III. Expanding on current resident patrol by supplying participants and maintenance with radios to report activities to police. This active participation will allow visitors to see potential resistance and relocate.**
- IV. Improve lighting by installing brighter porch lights that turn on automatically at dark. This will illuminate all entrances destroying anonymity that criminals desire.**
- V. Improve on criminal background checks. Arkansa House Bill 1799, written by the Executive Director of the Van Buren Housing Authority, was passed during the last Legislative Session. HB1799 allowed local Municipal Police to perform this service for their local Housing Authorities. However, the Arkansas Criminal Information Center is currently hindering the implementation of this Law as written. The Van Buren Housing Authority is a leader in the interpretation and implementation of this Law.**
- VI. A part time police officer to assist the officer currently assigned by Van Buren Police Department. Will train/support resident patrol, criminal background screening, criminal tracking, coordinate communications with other low income housing landlords, educational training for youth on drug abuse. This will increase exposure of Van Buren Police Department and Van Buren Housing Authority cooperation in stopping drug and criminal activity.**
