DECONCENTRATION ADMISSIONS POLICY

PUBLIC HOUSING:

In an ongoing effort for The Housing Authority to meet or exceed the laws and regulations regarding its public housing programs, the following Deconcentration Policy has been developed in order to comply with the Quality Housing and Work Responsibility Act of 1998, Section 513.

INCOME MIX TARGETING: To meet the requirements of the Act, and subsequent HUD regulations, at least 40 percent of families admitted to public housing by the Housing Authority must have incomes that do not exceed 30% of the area median. If 40% or more of the housing authority units are occupied by families whose incomes do not exceed 30% of the area median income, this requirement shall be considered as being met.

Additionally, to meet this goal, the housing authority may use the provisions of fungibility to the extent that the housing authority has provided more than seventy-five percent of newly available vouchers and certificates in its Section 8 program, including those resulting from turnover, to very poor families. The number of fungible housing credits used to drop the annual requirement for housing very poor families below 40 percent of the newly available units in public housing is limited to the lowest of the following:

1. The number of units equivalent to ten (10) percent of the number of newly available vouchers and certificates in that fiscal year; or,
2. The number of public housing units that (i) are in public housing projects located in census tracts having a poverty rate of 30% or more, and (ii) are made available for occupancy by, and actually occupied in that year by, families other than very poor families, or
3. The number of units that cause the housing authority's overall requirement for housing very poor families to drop to 30% of its-newly available units.

PROHIBITION OF CONCENTRATION OF LOW-INCOME FAMILIES: The housing authority may not, in meeting this income mix targeting, concentrate very low-income families, or other families with relatively low incomes, in public housing units in certain projects or certain buildings, i.e. high rise, within projects. The Housing Authority must review the income and occupancy characteristics of the housing projects and the buildings, i.e. high-rise, of each project to ensure that a low-income concentration does not occur.

DECONCENTRATION: The Housing Authority shall make every effort to deconcentrate families of certain **income characteristics** within the PHA complexes. To achieve this, the Housing Authority may offer incentives for eligible families having higher incomes to occupy dwelling units in projects predominantly occupied by eligible families having lower incomes, and provide for occupancy of eligible families having lower incomes in project predominantly occupied by eligible families having higher incomes. Incentives by the Housing Authority allow for the eligible family to have the sole discretion in determining whether to accept the incentive and the agency may not take any adverse action toward any eligible family for choosing not to accept these incentives. The skipping of a family on the waiting list to reach another family to implement this Deconcentration Policy shall not be considered an adverse action. As such, the Housing Authority will continue to **accept applications and place** the individuals on a waiting list. Selection will be made based on a combination of the local preferences and an income target mix. Any eligible family who qualifies as a higher income family may accept a dwelling unit assignment and be placed randomly into a vacant housing unit.

The Housing Authority will track the income mix within each project and building, i.e. high-rise, as an effort to avoid a concentration of higher or lower income families in any one building, i.e. high-rise, or development.

The HUD FY 01 Income Limits and Fair Market Rent Data show the Median Income for Florence is \$43,000.00 . Thirty (30) percent of the median income is \$ 12,900.00 .

ABC Housing Authority has 1000 units of Low Rent housing available. Per the QHWRA of **1998**, forty (40) percent of the leased units must be housed with families with incomes 30% or less of the median income, or 400 units. A breakdown of units **leased on 1/1/99 showed** that 600 units, 60%, of the families residing in our units have incomes at, or below, thirty (30) percent of median income, which surpasses the QHWRA of **1998** requirements by twenty (20) percent.

The percentage of families leased with incomes under thirty (30) percent of median income per project are:

"A" Project	50%
"B" Project	70%
"C" Project	60%

Each project has greater than forty (40) percent of the families with thirty (30) percent or less of the median income.

Monitoring will be conducted to confirm that at least forty (40) percent of all leased units will be within thirty (30) percent of median income.

Efforts through marketing and outreach shall be made to increase the number of families with incomes greater than thirty (30) percent of median income in the projects noted above in order to avoid concentrations of very low-income families in the projects as per the requirements of the QHWRA of **1998**.

INCOME MIX TARGETING: In each fiscal year, not less than 75% of the new admissions must have incomes at or below 30% of the area median income.

SECTION 8 PROJECT-BASED ASSISTANCE:

specific project must have incomes at or below 30% of the area median income. Other admissions to a specific project must be at or below 80% of the area median, with allowances for any HUD-instituted modifications.

Florence Housing Authority Public Housing Assessment System Resident Service and Satisfaction Survey Safety Follow-up Plan

The Authority's goal is to increase safety, as well as the feeling of safety, for all residents, as well as address the concerns contained in the HUD Resident Service and Satisfaction Survey. This plan shall detail steps and efforts planned or taken by the Authority to provide safe living conditions for all residents. In addition, this plan reinforces the Authority's commitment to safety and its desire to improve and increase the level of safety in and around all Public Housing communities in the City of Florence.

The Safety Follow-up Plan consist of the following actions and directives:

- 1) Continue to contract with the City of Florence for the services of four (4) sworn police officers to serve as Public Housing Community Police Officers. Their coverage area shall be in and around the Public Housing properties owned and managed by Florence Housing Authority.
- 2) The Authority shall provide two (2) police substations. One is in Cherry Hill Homes Central Maintenance Office (Building 452) and the second is in Carver Homes in a former project office (Building 1106).
- 3) The Community Police Officers shall meet with the Director of Housing Operations at a minimum of once per week to review all safety concerns, as well as resident problems that require police interdiction. The Executive Director and City of Florence Chief of Police will meet on an as-needed basis.
- 4) The Authority will make available to the City of Florence Police Department and interagency drug units requested vacant units in order to facilitate surveillance and pursuit. In addition, the Authority will provide meeting rooms for the Florence Police Department for programs such as Neighborhood Watch and Senior Citizens safety concerns.
- 5) The Authority shall involve the Community Police Officers in the development of the annual HUD Drug Elimination Grant, as well as any other grant that involves safety. In addition, the implementation schedule of the grants will be coordinated with the Community Police Officers.
- 6) The Authority will request input from the Community Police Officers as the Capital Fund Program is developed annually. Their involvement will particularly be requested during the physical needs assessment process.
- 7) Florence Housing Authority through its Community Police Program will cooperate with federal law enforcement efforts including weapon and drug sweeps after proper legal authority has been proven to the Authority's satisfaction.
- 8) The Public Housing Community Police Officers will provide counseling to youth at the Boys and Girls Clubs of Northwest Alabama and West Way Child Development Center on an as-needed basis and assist the Florence Parks and Recreation Department when sports leagues are operating.

- 9) The Community Police Officers will provide personal safety courses and institute neighborhood watch programs in Public Housing communities. Feedback from residents on the effectiveness of the programs will be requested on an informal basis.

The Authority will take the following actions:

- 1) Report all criminal activity to Florence Police Department.
- 2) Ensure policies and procedures are in place for tracking crime and crime-related activities that demonstrate that crime and crime-related problems are being tracked by development.
- 3) Institute a resident screening process that denies housing admission to those individuals who do not meet the legal criteria established by HUD or Florence Housing Authority Board of Commissioners.
- 4) Add and enforce Public Housing lease provisions that define safe behavior for residents with the correct level of repercussions for violating policy.
- 5) Add additional lighting where needed, and periodically check all outdoor security lights to make sure they are working.
- 6) Check during scheduled inspections all locks and outside doors to assure they are not in disrepair, and repair all locks that are damaged.
- 7) Provide children and teenagers a place to play. Build and/or maintain neighborhood playgrounds, and basketball courts. Continue youth programs to discourage crime.
- 8) Offer a course on basic home safety to residents.
- 9) Provide information on preventative drug-related services to residents, such as:
 - a) Preventative drug education
 - b) Referral sources for drug treatment programs
- 10) Work resident groups in the implementation of drug elimination grants.

RESIDENT BOARD MEMBER UPDATE

Florence Housing Authority informed City of Florence Mayor Eddie Frost on May 3, 2000 in writing of the requirement under Section 505 of the Quality Housing and Work Responsibility Act of 1998, more particularly described as 24 CFR Part 964. This set forth the required resident membership on the Board of Commissioners. Joyce M. Malone was selected as the Resident Delegate and was approved for such designation by Mayor Frost, after being personally interviewed by the Mayor on June 30, 2000. Ms. Malone is a Public Housing resident and has lived in Authority managed and owned Public Housing since March 6, 1998. Ms. Malone began attending meetings on June 30, 2000 and has been a great asset to the Board, because of her insights and perspectives. Ms. Malone has been very active in the Authority's Senior Services program and has family members living in other apartments in the Authority's Public Housing developments.

PROGRESS STATEMENT ON PHA GOALS

1. The PHA established the goal to reduce vacancies by 2% annually. This goal has been met as vacancies actually reduced by 22% over the past year.
2. The PHA has established the goal to increase the supply of housing by the year of 2004 if there is a proven need. Currently the housing need is being satisfied with the existing inventory, however, this situation will be monitored closely by the PHA in accordance with future trends for additional housing needs.
3. The PHA established the goal to improve the PHAs score. Last year the PHAs score was 93.3, this year the score was 92.7. While the PHA did not meet this goal, efforts will be implemented for the coming year to meet this goal.
4. The PHA established the goal to improve the SEMAP score. As of this date, the PHA has not received a SEMAP score.
5. This PHA established the goal of having units compatible with private market rentals by the year 2004. With the use of Capital Fund and CGP funds the PHA is on schedule meeting this goal.
6. The PHA established a goal to increase the average income of residents 2% annually. Over the past year, the average income increased by 7% which exceeded this goal.
7. The PHA established the goal to continue PHDEP efforts, hire police officers, and screen applicants. The PHA is meeting the requirements of this goal.
8. The PHA established the goal to maintain Magnolia Gardens I and II and Carver Heights Elderly Building as elderly housing. The PHA is meeting the requirements of this goal.
9. The PHA established the goal to increase the number of employed residents by 2% annually. Last year the PHA had 135 working residents currently there are 119 working residents. While the PHA did not meet this goal efforts will be made in the coming year to meet this goal.
10. The PHA established the goal to maintain 50 families in the FSS Program, provide funding to the West Way Child Development Center and the Boys and Girls Clubs of Northwest Alabama. This goal is being met.

11. The PHA established the goal to provide services for elderly families through senior services and PHDEP. The PHA is meeting this goal.
12. The PHA established the goal to setup computer laboratories in public housing communities. The PHA is meeting this goal.
13. The PHA established the goal to continue the policy to assure affirmative equal access for all applicants. The PHA is meeting this goal.
14. The PHA established the goal to make handicapped modifications to units exceeding 504 requirements based on individual need. The PHA is meeting this goal.

FLORENCE HOUSING AUTHORITY SECTION 8 HOMEOWNERSHIP PROGRAM CAPACITY STATEMENT

Florence Housing Authority affirms that it has the capacity to successfully operate and administer a Section 8 Homeownership Program. The Authority hereby demonstrates this ability by acknowledging that it has adopted as part of its Section 8 Homeownership Program policy the following two (2) provisions:

- a) A minimum homeowner downpayment requirement of at least 3 percent with at least 1 percent of the downpayment coming from the family's resources is required of all program participants.
- b) Financing for purchase of a home under the Authority's Section 8 Homeownership Program is required to be provided, insured or guaranteed by the State or Federal government, must comply with secondary mortgage market underwriting requirements; or must comply with generally accepted private sector underwriting standards.
