Attachment F: Progress of FY2000 Missions & Goals

The mission of the PHA is the same as that of the Department of Housing and Urban Development: To promote adequate and affordable housing, economic opportunity and a suitable living environment free from discrimination.

The Housing Authority of the City of Fitzgerald, Georgia has progressed with the implementation of our 5 Year Plan Missions and Goals by:

Modernization of GA Projects 5 & 6 (CIAP 99 & CFP 2000) 85% complete as of May, 2001; which includes: installation of range hoods with back splash, replace deteriorated floor tile, bathroom ceramic tile, repair shower enclosures, install insulation, furring strips and gypsum board on interior walls, replace electric receptacles, switches & covers, plumbing and interior doors as needed. The Housing Authority has utilized more than 25% of CFP 2000 for unit improvements.

The PHA improved the PHAS scores from 86.8 in 1999 to 90.0 in 2000. Our goal was to improve our score by 1%. We increased it 3.2%.

Customer Service and Satisfaction Survey: How the PHA addressed problem areas.

The PHA continues to respond to resident concerns and requests regarding safety and communication by informing residents through the PHA monthly newsletter & lease orientation at move in. The PHA holds monthly staff meetings to address resident concerns and complaints to ensure that customer service is efficient and courteous. The PHA staff continues to attend workshops on communication and human resources.

The PHA provides funds for police officers to attend training workshops and continues to contract with the local police department for additional police protection. The PHA also continues to maintain the Police Sub-Station in the projects.

The PHA will continue to have partnerships with other agencies; Communities in Schools, Headstart, Department of Family and Children Services, Board of Education and Family Connections.
