### **Required Attachment G: Brief Statement of Progress in Meeting the 5-Year Plan Mission and Goals**

**The mission of the Escanaba Housing Commission is to provide and maintain safe, affordable, quality housing in a cost-effective manner for all eligible persons, without discrimination. We will partner with our residents and others to enhance the quality of life in our community.**

The goals of the Escanaba Housing Commission, set forth in the 5-Year Plan for Fiscal Years 2000-2004 are listed below, followed by a progress report for each goal.

- 1) **Improve the Quality of Assisted Housing:** The Escanaba Housing Commission continues to utilize its Capital Funds to renovate and modernize our existing units. Last year the work items included many upgrades to the residents' apartments and our common areas. Future capital funds will be used to continue renovating our apartments, common areas, and outside areas. Also additional property was purchased to allow for the addition of resident parking spaces. We continue to maintain PHAS High Performer and have increased our Resident Satisfaction score in all scoring areas.
  
- 2) **Provide an Improved Living Environment:** The building security system is due to be renovated by August, 2001. This will allow for more security cameras and continuous 24-hour videotaping; our outside parking area will also have increased security surveillance and additional lighting. We have continued to conduct fire drills, testing the emergency call system and fire alarm systems, with all residents. The local Public Safety department partners with us in maintaining high security measures.  
Our Deconcentration Policy remains in place and is utilized whenever possible.
  
- 3) **Promote Self-Sufficiency and Asset Development of Families and Individuals:** We continue to partner with local home-health care agencies, Community Action, UPCAP, and other agencies to provide in-home care for our residents to help them maintain their apartments and assist in living independently. We hold monthly health clinics to assist our elderly population, as well as provide a congregate site for delivery of Meals on Wheels. Our staff delivers monthly food boxes to all elderly residents who qualify; help with filing yearly home-heating credits and monthly FIA reports. We have purchased two computers for the residents and provided training to any interested residents, and will be having three more computers donated for the residents use.
  
- 4) **Ensure Equal Opportunity in Housing for all Americans:** We continue to offer housing to all individuals regardless of race, color, religion, national origin, sex, family status or disability. We provide and maintain a suitable living environment for all our residents and offer accessible housing to persons with disabilities, making every reasonable accommodation to our units to help maintain the resident's independent life-style.
