The Balmorhea Housing Authority has used CIAP funds from 1998 and 1999 for upgrading the standards of the public housing development (22 units). It is the goal of this Housing Authority to continue the renovations, which are desperately needed within its development. In order to achieve this, all upcoming Capital Fund Programs will be divided among 3-4 units at a time over an eight year period or as long as it takes to complete total renovations. During total unit rehab, abatement of asbestos will be performed. Upon completion of the interior of the developments, the PHA will pursue to renovate the Office/Community Building, construction of a Maintenance storage, and landscaping, including off street parking, and outside storage units for the elderly units.
