The Housing Authority of the City of Pekin has two developments covered by the rule.

The initial assessments performed for the Broadway Apartments (IL 44-1) and Park Ridge Estates (IL 44-3) has resulted in a determination that is not appropriate for either development.

The basis for the determination is that :

1. The Housing Authority has expended significant Modernization dollars on the development in recent years.
2. There is not an active resident organization in existence to take over management of the property.
3. The Housing Authority does not have a Section 8 voucher program.
4. Removal of either development from public housing stock would have a significant negative impact on the Housing Authority's ability to service the remaining developments.
