In 1976, it was the intention of the Urban Renewal and Community Development Agency of Paris -Bourbon County to undertake a Section 8 Existing Housing Program as a supplement to its Community Development Block Grant Program. The initial allotment was 100 units. Since then the program has expanded to assist approximately 470 families, and has played a major role in making decent, safe, and sanitary housing available to lower income families in the area. It has also been instrumental in much of the upgradi ng of property which has been done by local owners.

It is the intention of the CDA to provide assistance for as many eligible families as possible, within the limits of its contract authority and resources. To this end, the CDA will support as many Housing Vouchers as its funding allows. The Agency expects to assist 470 families throughout Fiscal Year 2002.

The Paris -Bourbon County Urban Renewal and Community Development Agency administer the Section 8 Housing Assistance Program for Bourbon County. The Agency has an agreement with the Paris Housing Authority to work cooperatively to avoid duplication of assistance. The Agency also works closely with other government agencies, non -profit groups, and civic organizations to improve the educational, social, and cultural climate of Bourbon County. The Agency encourages the self -sufficiency of participant families by giving preference to families which have at least one adult member who works, and by delaying rent increases for one year if a family has an increase in income. The Agency constantly informs participant families of their Family Obligations. Those who violate the Family Obligations have assistance terminated. Those who owe the Agency money are required to repay.

Statement of Progress

The Agency is currently assisting 470 families and continues to be a major factor in the maintenance and upgrading of rental properties in Paris - Bourbon County.

During the past year, the Agency has worked on an individual basis with participating landlords, which has resulted in a significant decrease in the time taken to bring units into compliance with HQS.

Although we have not increased the percentage of families with income from wages, neither have we seen an appreciable decrease in that number, despite the current economic slowdown.

The Agency is involved in many collaborative efforts with other social agencies such as the Chamber of Commerce, the Community Action Agency, and the private sector, where partners include Kelly Services, and CBS Personnel Services, and community resource education at the public schools.
