Attachment I: Implementation of Public Housing Resident Community Service Requirement

PHA Responsibilities

(1) Eligibility Determination

The PHA will review every existing resident file to determine each Adult member's status regarding community service per the following guidelines.

- a. As family status is determined a registered letter or other certifiable document of receipt will be sent to each adult member of that family to notify them of their status (exempt or non-exempt) and explaining the steps they should immediately proceed with through their housing representative.
- b. The PHA will include a copy of the general information section of its Community Service Policy and a listing of PHA and/or third party work activities that are eligible for certification of the community service requirement.
- c. At the scheduled meeting with each non-exempt adult family member, not only will the parameters of the community service requirement be reviewed but also the PHA and/or third party work activities will be identified and selected for compliance with the annual obligation for certification at their annual lease renewal date.

(1) Work Activity Opportunities

The Evert Housing Commission has elected to provide to those adult family members that must perform community service activities the opportunity to select either PHA sanctioned work activities or Third Party certifiable work items. The administration of the certification process would be:

a. PHA Provided Activities.

When qualifying activities are provided by the Authority directly, designated Authority employee(s) shall provide signed certification that the family member has performed the proper number of hours for the selected service activities.

b. Third Party Certification

When qualifying activities are administered by any organization other than PHA, the family member must provide signed certification (see III A (c)) to the Authority by such third party organization that said family member has performed appropriate service activities for the required hours.

c. Verification of Compliance.

The Authority is required to review family compliance with service requirement, and must verify such compliance annually at least thirty (30) days before the end of the twelve (12) month lease term (annual re-certification time). Evidence of service performance and/or exemption must be maintained in the participant files.

d. Notice of Noncompliance.

If the Authority determines that, a family member who is subject to fulfilling a service requirement, but who has violated the family's obligation (a noncompliant resident) the Authority must notify the specific family member of this determination.

The Notice of Noncompliance must:

1. Briefly, describe the noncompliance (inadequate number of hours).
2. State that the Authority will not renew the lease at the end of the twelve (12) month lease term unless:

The resident or any other noncompliant adult family member enters into a written agreement with the Authority to cure the noncompliance and in fact perform to the letter of agreement.

- Or -

The family provides written assurance satisfactory, to the PHA that the resident or other noncompliant adult family member no longer resides in the unit.

This Notice of Noncompliance must also state that the resident may request a grievance hearing and that the resident may exercise any available judicial remedy to seek timely redress for the Authority's non-renewal of the lease because of a noncompliance determination.

- e. Resident agreement to comply with the service requirement.

The written agreement entered into with the Authority to cure the service requirement noncompliance by the resident and any other adult family member must:

1. Agree to complete additional service hours needed to make up the total number of hours required over the twelve (12) month term of the new lease.
2. State that all other members of the family subject to the service requirement are in current compliance with the service requirement or are no longer residing in the unit.

- f. The Evart Housing Commission has developed a list of Agency certifiable and/or third party work activities of which each non-exempt adult family member can select to perform their individual service requirement.

Attachment J: PHA's Policy on Pet Ownership in Public Housing Family Developments

PET POLICY FOR FAMILY DEVELOPMENTS

In compliance with Section 526 of the Quality Housing and Work Responsibility Act of 1998, the Evert Housing Commission will permit residents to own and keep common household pets in the housing unit. Animals that are an auxiliary for persons with a disability are excluded from this policy. The ownership of common household pets is subject to the following rules and limitations:

COMMON HOUSEHOLD PETS ARE DEFINED AS FOLLOWS:

1. BIRDS: Including Canary, Parakeet, Finch, Parrots and other species that are normally kept caged; birds of prey and game are not permitted. Not to exceed one (1) pair.
2. FISH: In aquariums or tanks, not to exceed twenty (20) gallons in capacity; poisonous or dangerous fish are not permitted.
3. DOGS: Not to exceed twenty-five (25) pounds in weight and fifteen (15) inches in height fully grown. Dogs must be spayed or neutered. Veterinarian's recommended/suggested type of dogs are as follows:
 - A. Chihuahua
 - B. Pekingese
 - C. Poodle
 - D. Terriers
 - E. Schnauzer
 - F Cockapoo
 - G. Dachshund
 - H. Beagle

No pit bull terriers will be permitted on Evert Housing Commission's property.

4. CATS: Must be spayed or neutered, de-clawed by age twelve (12) weeks, and should not exceed fifteen (15) pounds.
5. RODENTS: ONLY hamsters, gerbils, white rats or mice are considered common household pets. These animals must be kept in appropriate cages, and are not to exceed one (1) pair.
6. REPTILES: Reptiles other than turtles are not considered common household pets and are not allowed on EHC property.
7. EXOTIC PETS: At no time will the Evert Housing Commission approve of exotic pets such as snakes, monkeys, ferrets, rabbits, iguanas, spiders, livestock, wildlife, game pets, etc.

An additional Pet Security Deposit to be paid in full at time of admittance into the unit or upon obtaining a pet) is required. There shall be no additional deposit for pets other than dogs and cats. The additional deposit shall not preclude charges to a resident for repair of damages done on an ongoing basis by a pet. The resident is responsible for all damages caused by the pet and will reimburse the Commission for all costs it incurs in repairing such damages. The Evert Housing Commission may use the pet deposit **only** to pay reasonable expenses attributable to the presence of a pet in the project, including:

1. Cost of repairs and replacement to tenant's dwelling unit; and
2. Fumigation of tenant's dwelling unit.

The Evert Housing Commission will refund the unused portion of a pet deposit within a reasonable time after tenant(s) moves from the housing project, or no longer owns or keeps a pet in the housing unit.

To be in compliance with the Evert Housing Commission's Pet Policy, the Resident agrees to the following terms and conditions:

1. Before acquiring a pet, the owner must have on file with the Commission a notarized statement naming the persons accepting responsibility for the care of their pet in case of absence exceeding one (1) day.
2. Every pet must be registered, prior to admittance, with the Evert Housing Commission's

Management Office. Registration requires the following (as applicable):

- A. Proof of current license for dogs;
 - B. Proof of inoculation in accordance with applicable state and local laws, including rabies and distemper (dogs and cats);
 - C. Identification tag (dogs and cats);
 - D. Proof of spaying and neutering (dogs and cats);
 - E. Photograph of pet (no smaller than 3" x 5"); and
 - F. All cats must be de-clawed (front paws).
1. Only **ONE (1)** pet will be allowed per housing unit.
 2. No guest will be allowed to bring pets on the premises.
 - A. Residents will **NOT** be allowed to PET SIT.
 6. All pets must be on a leash when not in the owner's housing unit. Leash must be no longer than five (5) feet long.
 7. Litter boxes must be provided for all cats.
 8. Dogs must be provided with a pet bed or box (necessary to avoid wear and tear on the carpet).
 9. All fur bearing pets must wear flea collars at all times.
 10. Each pet owner shall be fully responsible for the care of the pet, including proper disposal of pet wastes in a safe and sanitary manner. Improper disposal of pet waste is a lease violation and may be grounds for termination. Pet owner shall be responsible for immediately removing feces dropped anywhere in the building or on the grounds. At no time should pet waste be disposed of in the toilet.
 11. No pet shall be tied up or left unattended anywhere at any time on Evart Housing Commission property.
 12. No dog houses will be allowed on any part of the Housing Commission's property. Pets other than dogs or cats shall be confined to an appropriate cage or container. Such a pet may be removed from its cage while inside the housing unit for the purpose of handling; however, it shall not generally go unrestrained.
 13. At no time will pets be allowed in lobbies or any common areas of the Housing Commission's property. All dogs and cats are required to be on a leash at all times when outside of the housing unit. The leash must be no longer than five (5) feet in length.
 14. All apartments with pets must be kept free of pet odors and maintained in a clean and sanitary manner. Residents' apartments may be subject to a monthly inspection.
 15. Pet owners shall maintain their pet in such a manner as to prevent any damage to their unit, yard or common areas of the community in which they live. The animal shall be maintained so as not to be a nuisance or threat to the health or safety of neighbors, EHC employees, or the public, by reason of noise, unpleasant odors or other objectionable situations. If pet poses a nuisance, such as excessive noise, barking or whining which disrupts the peace of the complex, the owner will be required to remove the pet from the premises if the Housing Commission's management so requests with TWENTY-FOUR (24) HOURS notice.
 16. Every **DOG** must wear a City Animal License, a valid rabies tag and a tag bearing the owner's name, address, and telephone number.
 17. Every **CAT** must wear a valid rabies tag and a tag bearing the owner's name, address and telephone number.
 18. Any litigation resulting from actions by pets shall be the sole responsibility of the pet owner.

The pet owner agrees to indemnify and hold harmless the Evert Housing Commission from all claims, causes of action damages or expenses, including attorney's fees resulting from the action or the activities of his or her pet.

- A. Pet owner agrees to immediately remove or allow the Housing Commission to remove from the premises any pet within the scope of this policy, at the resident's expense.
6. If a resident can not care for their pet due to an illness, absence, or death, and no other person can be found to care for the pet, after twenty-four (24) hours, the tenant hereby gives permission for the pet to be released to the Humane Society/Animal control, in accordance with their procedures. In no case shall the Evert Housing Commission incur any costs or liability for the care of a pet placed in the care of another individual or agency under this procedure. The Resident is to complete the attached form with the name, address, and telephone number of the person(s) who will care for the pet if the Resident is unable to do so. This information must be notarized and updated annually.
7. Violation of the Evert Housing Commission's Pet Policy will be grounds for termination of the lease.
8. Tenants will be required to keep their pet's license and identification tag current, this will be checked periodically and at random by management. Any tenant not in compliance with these requirements will have forty-eight (48) hours to comply or remove the pet from the premises.
9. Any tenant owning a pet, as stated in this policy, without authorization or not in compliance with this Pet Policy, shall be considered in violation of the lease.
