Brief Statement of Progress in Meeting Five-Year Plan Mission and Goals

Goal #1

The PHA has implemented policies to increase the attractiveness of the neighborhoods and follows up on a daily basis on all sites.

The PHA has installed signs in all neighborhoods and replaced all house numbers to create better curb appeal and to assist emergency workers in locating units.

Goal #2

All maintenance employees have been trained in HQS and UPCS requirements.

Changes have been implemented to increase inspection readiness.

A computer has been purchased to better comply with UPCS standards.

Goal #3

There are no immediate changes needed to the by-laws at this time.

The Executive Director provides a monthly report to the Board of Commissioners on financial and personnel matters.

Goal #4

Computers have been installed at the Carruth Street Clubhouse for resident use.

Dreambuilders mentoring continues to grow.

Due to renovation and growth of the Food Bank and Clothing Closet, they have been transferred to another neighboring community.

The Acworth Housing Authority performed a review of all covered developments to determine if there are any that would be covered by the Deconcentration Rule. The results are as follows:
