The Housing Authority continues to maintain High Performer status, but continually strives to increase its PHAS scores. The Housing Authority is currently utilizing 87% of its 2002 CFP money to renovate bathrooms in 10 apartments and 84% of 2001 & 2000 CFP money to install security screens in all apartments, install HVAC and renovate bathrooms in 10 apartments. 82% of 2003 CFP money is budgeted for the renovation of bathrooms in the final 10 apartments. The Housing Authority continues to work with DFACS and other government agencies. Some tenants have taken advantage of going back to school and becoming self sufficient. One tenant has bought her own Habitat for Humanity home by going back to school and getting a good job. Another has started her own business.
