Brief Statement of Progress in Meeting Five-Year Plan Mission and Goals

The Housing Authority of the City of Alamo has made significant progress in meeting the Goals and Objectives stated in the Five-Year Plan. The Authority has accomplished the following:

Continued coordination with the Wheeler County Department of Family and Children Services in regards to programs and services available to residents and the community.

Furnished the space for the Wheeler County Emergency Food Bank, working in conjunction with local agencies.

Continuing to upgrade the maintenance program to insure a sound preventive maintenance policy, work order completion and faster unit turnaround time.

Contracted a professional agency to perform the required annual inspections in order to meet new standards.

Conducted housekeeping inspections to insure that residents are caring for the inside of units in a safe and sanitary manner.

Scored very well on the Resident Assessment and Satisfaction Survey. No Follow-Up Plan was needed. The scores are listed by section on the following page.

Final plans have been established to install community signs and cluster mailboxes which should enhance the appearance of each property.

AHA employees continue to attend training sessions on an on-going basis.

The AHA continues to examine priorities and long range goals in regard to modernization needs. Resident Advisory Board members and all residents are encouraged to make suggestions and give input to the planning.

The main concern of the AHA is to ensure the safety and welfare of its residents and assist them in economic success. Any emergency situations or special circumstances will take priority if the need should arise.
