Statement of Progress Relating to the Five-Year Plan

Expand the supply of assisted housing

The Authority has worked to reduce vacancies in each development. Currently, the occupancy rate is 98.6%. The Authority is working to sustain this high rate of occupancy by keeping unit turnover days to a minimum.

The Authority is in the process of identifying funds that are available in order to create additional housing opportunities.

Improve the quality of assisted housing

The Authority is in the process of installing air conditioning in all unit by using funds through the Capital Fund Program. The Agency Plan includes a progress report on the FY2001 and FY2002 Capital Fund Programs and a projected plan for FY2003-2007.

The Authority is looking to demolish 8 units in the Shipp Street Development because they were damaged by a fire.

Increase assisted housing choices

The Authority is in the process of reviewing both the implementation of a site-based waiting list and homeownership program.
