EXECUTIVE SUMMARY

The Lebanon Housing Authority has prepared this Agency Plan in compliance with Section 511 of the Quality Housing and Work Responsibility Act of 1998 and the ensuing HUD requirements.

We have adopted the following mission statement to guide the activities of the Lebanon Housing Authority.

The mission of the Lebanon Housing Authority is to promote adequate, affordable housing, economic opportunity, and a suitable living environment for the families we serve, without discrimination.

We have also adopted the following goals and objectives for the next five years.

The goals and objectives adopted by the Lebanon Housing Authority are:

Goal One: Manage the Lebanon Housing Authority's existing public housing program in an efficient and effective manner thereby qualifying as at least a standard performer.

Objectives:

1. HUD shall continue to recognize the Lebanon Housing Authority as at least a standard performer each year through December 31, 2005.
2. The Lebanon Housing Authority shall make our public housing units more marketable to the community as evidenced by an increase in our waiting list to one that requires a 3 month wait for housing by December 31, 2005.
3. The Lebanon Housing Authority shall promote a motivating work environment with a capable and efficient team of employees to operate as a customer-friendly and fiscally prudent leader in the affordable housing industry.

Goal Two: Enhance the marketability of the Lebanon Housing Authority's public housing units.

Objectives:

1. The Lebanon Housing Authority shall achieve proper curb appeal for its public housing developments by improving its landscaping, keeping its grass cut, making the properties litter-free by December 31, 2001.
2. The Lebanon Housing Authority shall continue its modernization plans through the available Capital Fund with all of its public housing units.
3. The Lebanon Housing Authority shall become a more customer-oriented organization.
4. The Lebanon Housing Authority shall achieve a level of customer satisfaction that gives the agency the highest score possible in this element of the Public Housing Assessment System.

Goal Three: Provide a safe and secure environment in the Lebanon Housing Authority's public housing developments.

Objectives:

1. The Lebanon Housing Authority shall promote programs to reduce crime in its developments so that the crime rate is less than their surrounding neighborhoods by December 31, 2004.
2. The Lebanon Housing Authority shall adequately reduce its evictions due to violations of criminal laws by December 31, 2005, through aggressive screening procedures.

Goal Four: Manage the Lebanon Housing Authority's tenant-based program in an efficient and effective manner thereby qualifying as at least a standard performer under SEMAP.

Objectives:

1. The Lebanon Housing Authority shall encourage people who use its tenant-based program to become homeowners by December 31, 2005.
2. The Lebanon Housing Authority shall achieve and sustain a utilization rate of 90% by December 31, 2004, in its tenant-based program.
3. The Lebanon Housing Authority shall attract 15 new landlords who want to participate in the program by December 31, 2004.

Goal Five: Deliver timely and high quality maintenance service to the residents of the Lebanon Housing Authority.

Objectives:

1. The Lebanon Housing Authority shall create an appealing, up-to-date environment in its developments by December 31, 2004.
2. The Lebanon Housing Authority shall achieve and maintain an average response time of 3 days in responding to routine work orders by December 31, 2002.
3. The Lebanon Housing Authority shall achieve and maintain an average response time of 24 hours in responding to emergency work orders by December 31, 2001.

Our Annual Plan is based on the premise that if we accomplish our goals and objectives we will be working towards the achievement of our mission.
