The Housing Authority continues to be 100% occupied, providing housing for approximately one-fifth of the Town of Hertford's population. We work directly with the police department and enforce strict admissions and continued occupancy policies. We work hand-in-hand with the Department of Social Services and other agencies within the town and surrounding areas to provide opportunities for our residents to become integrated into the main stream of the population. This includes transportation and support to assist our residents with educational goals and participation in programs to encourage self-sufficiency.

Hertford Housing Authority continues to spend 100% of its Capital Funding to modernize and maintain its public housing units. We have a 93 PHAS score.
