The City Consolidated Plan compliments NHA residents by:

The City of Northampton continues to make housing a priority.

The Consolidated Plan of the City and the 5 Year Plan of the NHA were developed based on mutual consultation, and the plans provide complementary steps for meeting the needs of the City. Both the City and the NHA, therefore, are committed to providing resources to address the homelessness, preserve existing affordable housing, and develop new housing opportunities (either through development or first time homebuyer programs) that meet the needs of the City's population. The City has been generous in it's use of financial resources in supporting the recreational needs of young public housing residents, and devoted CDBG funds for housing mediation, ESL classes, and emergency fuel assistance, among others. The NHA, for it's part, is in the process of developing 20 additional units of affordable housing, has devoted resources and professional expertise to preserve affordable housing, and has provided free space for ESL and job training activities.
