We have a better working relationship with our local police department and continue to report residents when we believe there is drug activity. We have partnered with community agencies, organizations and churches for furthering activities with our residents and recently made application for Community Service Tax Credits through the State of Kansas to construct a homeless and transitional living facility.*

We were unable to complete the designation of our high rise to elderly only because it was contingent upon the construction of additional units. We collaborated with another agency for a HUD 811 Project and when the application was not funded, our application for designation had expired.*

Since 2000 we have enrolled eleven Section 8 residents in the FSS Program. One individual graduated from the program in 2003 with an escrow account. From 2002 to the present time, eight (8) residents have continuously participated with one individual establishing an escrow account. We maintain memorandum of agreements with other community agencies for improved service delivery.*

The Housing Authority of the City of Chanute, Kansas has prepared this Annual PHA Plan in compliance with Section 511 of the Quality Housing and Work Responsibility Act of 1998 and the ensuing HUD requirements.

The purpose of the Annual Plan is to provide a framework for local accountability and an easily identifiable source by which public housing residents, participants in the tenant-based assistance program and other members of the public may locate basic PHA policies, rules and requirements related to the operations, programs and services of the agency.

The Mission Statement and the Goals and Objectives were based on information contained in our jurisdiction's Consolidated Plan and will assure that our residents will receive the best customer service.

Excellent customer service and fulfillment of the Mission Statement and Goals and Objectives is ensured by implementation of a series of policies that are on display with this Plan. The Admissions and Occupancy Policy and Section 8 Administrative Plan are the two primary policies on display. These important documents cover the public housing tenant selection and assignment plan, outreach services, PHA's responsibility to Section 8 owners/landlords, grievance procedures, etc.

The most important challenges to be met by the Housing Authority of the City of Chanute during FY 2005 include:

- *Reduce drug and alcohol abuse through available resources.*
- *Preserve and improve the public housing stock through the Capital Funds activities.*
- *Increase the supply of assisted and affordable housing.*
- *Increase homeownership opportunities.*
- *Involve the public housing residents and the Section 8 participants through the Annual Plan Resident Advisory Board and support of the resident councils.*
- *Train staff and commissioners to fully understand and take advantage of opportunities in the new law and regulations to better serve our residents and the community; and*
- *Identify, develop and leverage services to enable low-income families to become self-sufficient.*

In closing, this Annual PHA Plan exemplifies the commitment of the Housing Authority of the City of Chanute to meet the housing needs of the full range of low-income residents. The Housing Authority of the City of Chanute, in partnership with agencies from all levels of government, the business community, non-profit community groups, and residents will use this plan as a road map to reach the "higher quality of life" destination for the City of Chanute and Neosho County.

A. PHA Progress in Meeting the Mission and Goals Described in the 5-Year Plan

The Housing Authority of the City of Chanute has been successful in meeting the goals and objectives established for the period FY 2000 – 2004. The PHA has received positive reporting on HUD's Resident Assessment and Satisfaction Survey throughout the 5-year period. With the encouragement of the PHA, Resident Councils have been established. The PHA now has a Resident Services Coordinator and a FSS Coordinator on staff. The PHA has partnered with local agencies, organizations and churches to promote any and all support services available in our community for our residents. In addition, we have developed a closer relationship with the local Police Department which has been beneficial in fighting crime and drug issues. The PHA has provided Commissioners and staff with opportunities to attend training seminars and conferences, thus keeping them abreast as new rules and regulations by HUD were introduced. The policies were updated to reflect the QHWRA changes and are currently being updated to address the HUD's most recent concerns regarding Rental Integrity Monitoring (RIM) and Up-front Income Verification (UIV) issues. The Community Service requirement for public housing residents was reinstated. Through collaboration with other community agencies and organizations, the PHA has made application for community service tax credits through the State of Kansas for the development of a homeless and transitional housing facility. In the area of modernization, the PHA has utilized capital funds for major property upgrades such as re-roofing the high rise, new chiller for the high rise, and painting balcony railings, new siding on family houses, new storm doors on elderly housing, paving and visit ability to family units.
