**Planning Process:**

The Barnstable Housing Authority has made a good faith effort to meet all the requirements of the PHA Plan. The documentation required has been a part of our internal Management Plan and remains available at the agency. The BHA continues to approach the development of this plan as an opportunity to strategically plan for the year 2005 and beyond.

The Local Comprehensive Plan is a 5 year plan which coincides nicely with the development of the PHA/HUD Plan. The BHA strives to have compatible goals in each plan. The 10 Year Plan to End Homelessness annually reviews its progress towards ending homelessness. The 1 year action plan of the Town of Barnstable Housing Committee also helps the BHA to focus on preservation and production of affordable housing.

**Community Housing Planning Process:**

The BHA continues to be involved in the Town of Barnstable's affordable housing planning strategy. The Executive Director serves as the liaison to the local Barnstable Housing Committee.

The Town of Barnstable has a certified Housing Plan through the Department of Housing & Community Development (DHCD). A significant section of this plan is a Housing Needs Study. The Town's priorities are: Rental Housing, Home Ownership, Housing for Seniors, and Housing for Special Needs Populations. The BHA endorses these 4 priorities.

The Plan reflects both our internal management of federal programs and our role in the community as a provider of affordable housing. The BHA manages thirteen different federal, state and local housing programs. Because of the shortage of rental housing for low income families, the BHA started the Rental Acquisition Program (RAP). The BHA exceeded its goal to purchase five units a year for the

period of five years using a combination of grant money and conventional funding from local banks and produced 32 units.

The BHA is looked to by the Town as the lead affordable housing agency in Barnstable. The BHA also works to promote affordable housing opportunities throughout Barnstable County.

**Resident Involvement of Board:**

The BHA is governed by Massachusetts General Law, Chapter 121B. Under this statute, our Board of Commissioners is elected, with one of five members appointed by the Governor. The BHA has been fortunate over the years to have residents of public housing run for the elected positions. Unfortunately, this year our tenant declined to run for re-election and no other tenants voiced interest in running to fill her vacant position. The BHA depends on comments of its RAB for input into the Plan process.

**Summary:**

The BHA is an active agency with lengthy wait lists for each program. Our federal conventional housing and the Section 8 Programs are vital components of our housing supply for the Town.

The BHA is in the process of beginning engineering of the property as staff pursues available funding for construction. The Town of Barnstable has been supportive through deeding tax title properties to the BHA. The BHA will implement a scattered site development program for these buildable lots.

The BHA has had a very productive past 5 years. The agency has exceeded projected goals for preservation and production of affordable housing. This has been accomplished through collaboration with the County and Town governmental leaders. The BHA believes this spirit of cooperation will continue through the term of this annual plan.

The management of the BHA has remained stable. The agency has experienced no audit findings and consistently scored well on management ratings.

The BHA through regionalization efforts with other local housing authorities has revitalized the FSS Program. Lack of staffing and high housing costs has delayed

implementation of the Section 8 Home Ownership program. We hope to reverse this in the next 5 years.

The BHA accomplished the 2000 Goal of creating a Housing Land Trust . This independent non-profit is currently developing 30 units of family housing in Barnstable.

The BHA was a participant in the successful 2000 Cape Cod Housing Summit. The lasting product of this summit was the creation of housing committees in each of the 15 towns on Cape Cod. The Executive Director is the liaison from the BHA to the Town of Barnstable Housing Committee. The Housing Committee prepares one year action plans which are approved by the Town Council.

In the last 5 Year Plan, the BHA set a goal of producing 15 units of new rental housing. Through the dedication of the Town's political leaders Barnstable added 156 new units of affordable housing in the year 2003 alone! We hope to continue to produce housing at this pace in the future.

**Insert RAB Minutes & Comments**

On August 16, 2004, the Resident Advisory Board met to discuss the Barnstable Housing Authority's 5 Year Plan and the Annual Plan for 2005. Members, Amelia Fenner, William Rego and Jane Whitney attended the meeting which was facilitated by Maria Chesky, BHA Service Coordinator. Comments and suggestions were as follows:

Safety Issues

The RAB would like to see at least 3 fire drills conducted annually. Also they would like the exterior doors painted red and signage installed which alerts residents not to prop open doors. Also the RAB suggested that the BHA look into purchasing a generator to be used when there are emergency power outages.

Modernization-CFP

Members discussed and established a list of items they would like to see the BHA include in their modernization efforts at the Colony House. Some of these items will be included in routine maintenance planning. They are: cleaning of exterior windows annually, nails lifting on patios which need repair, dampness in first floor units, signs for the parking lots signifying "Tenant Only Parking", more fire alarm strobe lights for hearing impaired. Lack of enough parking was a big topic of concern and the RAB suggested that BHA employees park elsewhere off site to free up more resident and visitor parking. This will be taken under advisement by the Executive Director. Suggestions for CFP funding by the RAB were: Off site maintenance garage, new furniture for the newly renovated sunroom, emergency generator, new thermostats in each

apartment which are easier to read. The RAB reviewed the current 2004 CFP projects and those planned for the future and recommended that the BHA continue working as quickly as possible to complete items listed. It was noted that the next major project to be undertaken will be the replacement of the front patio which consists of slate which is crumbling and in disrepair. The BHA Maintenance Supervisor has been gathering quotes and staff is hoping to begin this work in late Fall, weather permitting.

### Summation

The RAB concurs with the information and direction which the BHA has laid out for 2005 as well as in the Five Year Plan. Members were appreciative of the improvements made at Colony House this past year especially the new patio/sunroom which replaced the old greenhouse. They also suggested that the BHA establish a formal certification of merit program to acknowledge those residents who volunteer their time to help make the development a better place to live for all.

Issues of supply and demand have negatively impacted affordable rentals in the area even with the financial assistance a voucher provides. Preservation of affordable housing units has become a necessary tool in providing affordable housing in the Town.
