NHA public spaces continue to be made available for senior citizens'

activities, WIC programs, AA, public safety training meetings and other meetings of public interest.

B. Strategy for Addressing Needs

The agency will: quickly determine eligibility and immediately communicate eligibility to reassure applicants' confidence in timely admission to assisted housing; will stay in communication with eligible applicants in both Spanish and English language; and will continue an outreach to the elderly community. The reason for choosing these strategies for the FYE 06/06, respectively, is the tendency of applicants to lose interest if they have a bit of a wait, to facilitate a greater comfort level in a language of choice and to build a wait list for the difficult-to-market, elderly units in this community.

- Participate in the Consolidated Plan development process to ensure coordination with broader community strategies

The agency was successful in meeting occupancy goals. The PHAS scores improved and the RASS component score improved during the measurement period. More than fifteen families were assisted either directly or indirectly into homeownership. The existing housing stock was maintained and improved with additional security lighting and landscaping. CFP projects to modernize the stock are ongoing. Good attendance is observed in the on-site GED/ABE/ESL classes offered to resident and community families, Attempts to provide transportation for elderly and disabled residents were only marginally successful, however. Services provided were not used enough to maintain them. The agency continues to fulfill its mission as described.
