**Executive Summary**

The Housing Authority of the County of Greene is a medium Capital Funded agency located in Greene County, Pennsylvania. The HACG manages five developments consisting of 290 units of public housing.

The mission of the HACG is:

To provide adequate and affordable housing, economic opportunity and a suitable living environment without discrimination for low-income, very low-income families, persons with disabilities, and the elderly. The Housing Authority is committed to excellence in providing quality housing in an environment which will ensure all residents opportunity, access to resources, and the expectation that their communities will be safe, secure places to live and realize their potential.

The HACG will accomplish its mission ideals through its goals and objectives:

1. Providing decent, safe and affordable housing in our community.
2. Ensuring equal opportunity in housing for all.
3. To provide timely response to resident request for maintenance service.
4. To return vacated units with new resident in 20 days.
5. To continue to enforce our "One Strike" policies for residents and applicants.
6. To improve and/or maintain our financial stability through aggressive rent collections and improved reserve position.

The HACG's financial resources include an operating fund, capital fund, dwelling rental income and Section 8 Administrative fees which will be used to operate the agency in the most cost effective means possible and still provide services and activities for it's residents.

The HACG has assessed the housing needs of Waynesburg and the surrounding Greene County area and has determined that it is currently, and will continue, to meet the housing needs of the community to the extent practical for a small agency. The HACG has an approved Deconcentration Policy and has utilized Local Preferences to attract and encourage applicants that can qualify for public housing. The HACG has determined that its housing strategy complies with the state of Pennsylvania's Consolidated Plan

The HACG has an updated Admissions and Continued Occupancy Policy, Dwelling Lease, and Grievance procedures to comply with all QHwRA requirements. The HACG has established a minimum rent of \$25.00 and elected to recognize its flat and ceiling rents as synonymous and chosen to select the local Fair Market Rents (FMR) to determine the dollar value of same.

The HACG has conducted a physical needs assessment to determine its modernization requirements and has developed an Annual and 5-year Action Plan to address its Capital Improvements.

The HACG has plans to dispose of property.

The HACG has jointly addressed with the local police department to develop safety and crime prevention that adequately meets the needs of its residents.

The HACG has developed an agency wide Pet Policy that allows any family to have a pet within adopted guidelines.

The HACG has certified that it has and will continue to adhere to all Civil Rights requirements and will affirmatively further fair housing. In addition, the HACG has included a copy of its most recent fiscal year audit reports (2003) as part of the supporting documentation of this Housing Authority's Annual Agency Plan.

The HACG is a continuing High-Performing Agency and as such has submitted a Streamlined Annual Plan for fiscal year 01/01/2005-12/31/2005.

### **13. Capital Fund Program Five-Year Action Plan**

**PHA Policy 3.A.(6)**

**Section from A&O Policy - C6.0 Deconcentration and Income Mixing:**

**1. Objective**

The HACG shall make every effort possible to provide for deconcentration of poverty and income mixing in its communities by bringing higher income residents into lower income developments and lower income residents into higher income developments.

To this extent the HACG shall insure that not less than forty percent (40%) of all new admissions shall be families whose income at the time of their admission does not exceed thirty percent (30%) of the area's median income.

The HACG does not intend to utilize and/or impose any specific income or racial quotas nor will the HACG offer incentives for eligible families to occupy units in developments predominately occupied by families having either lower or higher incomes.

**2. HACG Deconcentration Policy**

It is the policy of the Housing Authority of the County of Greene (HACG) to house families in a manner that will prevent a concentration of poverty families and/or concentration of higher income families in any one development. The specific objective of the HACG is to house no less than 40% of its inventory with families that have income at or below 30% of the area median income by public housing development. Also the HACG will take actions to insure that no individual development has a concentration of higher income families in one or more of the developments. To insure that the HACG does not concentrate families with higher income levels, it is the goal of the HACG not to house more than 60% of its units in any one development with families whose income exceeds 30% of the area median income. The HACG will track the status of family income, by development, on a regular basis by utilizing income reports generated by the HACG.

To accomplish the deconcentration goals the HACG will take the following actions:

A. At the beginning of each fiscal year, the HACG will establish a goal for housing 40% of its new admissions with families whose incomes are at or below the area median income. The annual goal will be calculated by taking 40% of the total number of move-ins from the previous fiscal year.

B. To accomplish the goals of:

1. Housing not less than 40% of its inventory on an annual basis with families that have incomes at or below 30% of area median income, and,

2. Not housing families with incomes that exceed 30% of the area median income in developments that have 60% or more of the total household living in the development with incomes that exceed 30% of the area median income, the HACG's Tenant Selection and Assignment Plan, which is a part of this policy, provides for the utilization of local preferences with regards to applicant selection from its waiting list.

- a. Three (3) of the developments in Authority inventory are subject to the Required Initial Assessments

- c. The Housing Authority of the County of Greene certifies that it has reviewed each development's operations as public housing and considered the implications of converting the public housing to tenant-based assistance. The PHA has considered factors such as overall cost (PILOT, Maintenance costs, remodeling, accrual, insurance, relocation, demolition), vacancy rate, location of units, PFS, etc. in making this determination. Also, local factors such as rural population scattered in large areas, a large percentage of population relying on public assistance, SSI, and SS as sole income, poor availability of decent, safe, and sanitary housing through private landlords, etc., were all determining elements in the PHA final analysis. The Housing Authority also operates a total of 290 public housing units that include both covered and exempt developments.
- d. No PHA developments have been determined to be appropriate for conversion based on the Required Initial Assessments.
- e. Required Initial Assessments have been completed.

\* The Housing Authority of the County of Greene has exceeded the Established Income Range in this development as a result of consistency with, and furtherance of, two sets of goals - the goals of deconcentration of poverty and income mixing as specified by the US Housing Act of 1937 (bringing higher income tenants into lower income developments and vice versa); and the local goals and strategies contained in the PHA Annual Policy.

Thompson Gardens is part of the HACG program/strategy designed to deconcentrate poverty, promote income mixing in public housing, and increase the incomes of public housing residents.

This Development consists of both studio and one bedroom apartments and is located within walking distance of a hospital, numerous physicians' offices and retail establishments. Thompson Gardens is not a designated site at the present time and this location is favorable to both working residents and elderly, retired persons.

The EIR has been exceeded by only 3%. The Housing Authority anticipates this percentage will again fall within established guidelines in the coming year as a result of completion of assessable units which have been unavailable as a result of construction delays.

**STATEMENT OF PROGRESS  
MEETING THE FIVE-YEAR POLICY  
MISSION AND GOALS**

The goal of the Housing Authority of the County of Greene through this next five year period is again to work to continue to improve the quality of life for its housing residents through both PHA and local communities.

To further improve our customer service operation-from administration to maintenance-we have established a comprehensive plan which is committed to resident satisfaction. It focuses on enhancing communication between residents and the PHA while meeting HUD requirements and local community needs.

The executed Pet Rider to Lease is retained in the resident's file and is reviewed on an annual basis with the resident providing updated veterinary information. The pet is also brought to the PHA office on an annual basis to be photographed.
