## **Executive Summary (optional)**

The Sweetwater Housing Authority has completed this Agency Plan in consultation with SHA residents and the local communities. The Plan was discussed with the Resident Advisory Board on August 19, 2004. The public was afforded an opportunity to review the plan and offer comments at a public hearing held on October 7, 2004. The Annual Agency Plan is summarized as follows:

1. Housing Needs

The SHA's current waiting lists are excessive and the demand for public housing (38) and Section 8 (104) is evident. The greatest demand is for small to medium bedroom units (1, 2 and 3 bedroom units).

2. Financial Resources

The SHA expects to expend approximately \$1,285,885 in the year 2005 for operations, capital improvements and administrative costs.

3. Eligibility, Selection and Admission Policies

The SHA has revised its standard operating policies and Section 8 policies to comply with the requirements of the QHWRA through regulations published in the Federal Register on March 29, 2000. These policies will continue to be updated as HUD issues further guidance.

As required under this section of the plan and by regulation published in PIH Notice 2001-4, the SHA has reviewed its developments relative to income. The SHA has determined that they do not have a problem with concentration of high or low-income families. Further, the SHA has revised their admission policies to assure that a concentration does not occur in the future.

4. Rent Determination-Discretionary Policy

The SHA's adopted discretionary rent policies include:

- ✓ Ceiling Rents
- ✓ Flat Rents
- ✓ \$50.00 minimum rent for Public Housing and Section 8.

5. Capital Improvements

The SHA's projected funding under the Capital Fund Program is \$303,625.

The focus for the 2005 program year is to repair porch awnings in Development TN016-001; perform kitchen renovations in Development TN016-004; install fire rated attic access doors in Development TN016-005 and perform site improvements, bathroom renovations, install HVAC replace water heaters and install dryer vents in Development TN016-006. Additional improvements include installing range hood mounted fire extinguishers in the Authority’s “elderly” units.

6. Demolition and/or Disposition

The SHA has no current plans for any additional demolition or disposition.

7. Homeownership

The SHA has no current plans to develop a Homeownership Program.
