The Housing Authority of the City of Commerce has been successful in achieving its mission and 5 year plan goals during the period FY 2000-2004.

Concerning modernization the PHA has done substantial renovation at all sites, at all units and all facets of construction. To include, storm sewers, sewer, water, electrical line, lighting, painting and energy efficient upgrades.

Concerning self-sufficiency and crime and safety, PHA efforts reduced crime in the communities through, the partnering with local law enforcement agencies to patrol sites during "off duty" hours and continue to keep the flow of traffic through complexes to a minimum. Informing the PHA of activity which is not conducive to maintaining a "safe and peaceful" environment through police reports, and personal interaction with local law enforcement and City management. The PHA has been successful in enforcing our Zero Tolerance Policy regarding criminal activity, by terminating leases and removing those that violate such policy; therefore, protecting other resident's rights to a peaceful enjoyment of their complex with cooperation from local law enforcement and judicial offices. In addition, the PHA has extended its statute of limitations for past criminal history when screening new applicants from 3 years to 5 years with the option to consider older information if history indicates a pattern of criminal behavior. This has afforded the PHA the latitude to screen out potential violators of the Zero Tolerance Policy and ensuring current residents a safe environment to reside in

Concerning improving the quality of life, PHA has used capital funds to provide a program for the Community Service residents and assist them with complying to the Community Service Policy. Community Centers are being utilized by various civic and community organizations; as well as, the Commerce ISD. High speed internet is accessible at community centers through the Commerce Community Network; thereby, allowing residents availability to perform job search, build resumes, work on homework assignments, etc. PHA residents can take advantage of a program through the Commerce ISD, known as K-12 planet. A program that allows parents to access homework assignments and grades for their school age children. The Executive Director worked with the Superintendent of Commerce ISD in providing availability for the Community Center and the PHA provided Technical assistance with the computer system and program.

To ensure compliance with the Public Housing Reform Act of 1998 and the HUD Rental Housing Integrity Improvement Program (RHIP), every policy was reviewed and updated as needed. Most significant was the update to the Admissions and Occupancy Policy and the Section 8 Administrative Plan.

Concerning ensuring equal opportunity outreach efforts have been made by making renewed partnerships with community groups and medical facilities.
