## **Attachment D**

### **Statement of Progress in Meeting the Five-Year Plan Mission and Goals**

**May 3, 2006**

**During the previous year, the JHA has made great strides in making that statement a reality for its residents. Last June, the JHA was awarded a Voluntary Graduation Incentive Grant for being ranked number one in the state of Georgia and number four in the nation for end of participation (EOP) of residents receiving federal housing assistance. A large factor in this accomplishment has been the development over the last year of a resident services program, under the direction of the Director of Resident and Employee Services. This position was added to the organizational chart of the JHA to bolster the economic and educational development of our residents. The recent modernization to the JHA Central Office also incorporated a Resident Training Center, which will help the JHA to continue to fulfill our mission statement.**

#### **Strategic Goal #1:**

- **Reduce public housing vacancies:**
  - **During the previous year, 27 apartments that had been taken offline by the previous administration were modernized using CFP Grant funds and are now back online to increase the stock of apartments for the JHA. The vacancy rate for the current fiscal year to date is 4.8%, which is an improvement over last year's rate.**
- **Improve public housing management: PHAS Score**
  - **The JHA FY 03 PHAS score was a 53 under the previous administration. The FY2004 score was an 83, or an improvement of 30 points. The FY2005 score has not been released.**
- **Increase Customer Satisfaction:**
  - **The JHA received a 4.2 out of a possible 5 points on the REAC FY2004 Resident Survey. The JHA was not required to complete a follow-up plan as all scores were above 75%.**
- **Renovate or modernize public housing units:**
  - **27 units were brought back on-line after undergoing modernization during the current fiscal year.**
- **Provide an improved living environment:**
  - **Through physical improvements and resident services improvements as noted above, the JHA has improved the living environment.**

- **Implement Public Housing Security Improvements:**
  - **New street signs have been installed to combat speeding and loitering. The JHA also has a close relationship with the Jesup Police Department, which coordinates regular license checks and speed checks on JHA properties to enhance security. The JPD also reports all incidents on JHA properties to management promptly. In addition, the JHA has recently constructed security fences surrounding all playground areas.**
- **Promote self-sufficiency and asset development of families and individuals:**
  - **Currently, only 47 of 411 residents are required to complete community service per HUD requirements. The JHA has also partnered with many community organizations to provide resident services.**
- **Ensure equal opportunity and affirmatively further fair housing objectives:**
  - **The JHA strictly follows its screening and application procedures as defined in our ACOP, as can be attested by zero findings on our FY2005 annual audit.**
