The Consolidated Plan supports the Annual Plan of the Housing Authority of the City of Fernandina Beach by supporting the concept that safe, sanitary and affordable housing should be the benchmark for every low-and very-low income family within our boundaries. There are, however, obstacles to meeting the needs in some underserved communities:

- Growing shortage of affordable housing for low-and very-low income families (particular rental housing);
- Low production of affordable housing compared to the need;
- Scarcity of affordable housing sites due to escalating costs of real estate;
- High cost of land and construction;
- Reduction in Federal and State funding for affordable housing;
- High cost of housing in comparison to income.

With the creation of economic opportunities through creative public/private partnerships, in addition to expanding our base with our HUD partners we may be able to hurdle some of these obstacles. Additionally, the Housing Authority has initiated an on-going effort to ensure equal opportunity to housing for all our citizens and to affirmatively further Fair Housing.
