two

factors to be the greatest reasons that applicants are denied admission to housing. This benefits both the applicant and the PHA in that the applicant is not waiting a long time just to be denied and the waiting list is more easily managed by the PHA. Other elements of eligibility are verified while on the waiting list and updated every three months.
