Criteria for Substantial Deviation and Significant Amendments

Substantial Deviation from the 5-year Plan:

This includes changing the Authority’s Goals and Objectives. The Punta Gorda Housing Authority (PGHA) will consider the following to be a substantial deviation from the 5-Year Plan:

- The addition of new activities that do not otherwise further PGHA’s stated mission or further the goals as set forth in the current 5-Year Capital Plan.
- Insufficient budget authority from HUD necessitating the need to terminate program activities.
- An exception to this definition will be made from any new activities that are adopted to reflect changes in HUD regulatory requirements or as a result of a declared emergency; such changes will not be considered a substantial deviation by PGHA.

Significant Amendment or Modification to the Annual Plan:

A “Significant Amendment or Modification” to the Annual Plan is a change in a policy or policies pertaining to the operation of the Authority. This includes the following:

PGHA WILL CONSIDER THE FOLLOWING TO BE SIGNIFICANT AMENDMENTS OR MODIFICATIONS:

- Significant changes to rent or admissions policies or organization of the waiting lists;
- Addition of new program initiatives not included in the current 5-Year Capital Plan;
