On an ongoing basis, the Capital Fund Program is used to improve the physical condition of the housing stock. Future plans are included in the FY2007 Capital Fund Program Annual Statement and Five-Year Plan which is included in Attachment ga189a01.

The Housing Authority continues to score well on the Resident Assessment and Satisfaction Survey issued by the Department of Housing and Urban Development. The results of the FY2006 survey are included in Attachment F.

The Authority scored 92 out of 100 on the most recent Public Housing Assessment System (PHAS) and is considered to be a High Performing PHA.

The Authority continues to follow all Federal Regulations pertaining to the admissions and occupancy of public housing.

## **Attachment F**

### **Resident Assessment and Satisfaction Survey**

Once every other year, the Department of Housing and Urban Development (HUD) sends a satisfaction survey to the residents of the Housing Authority of the City of Metter. The survey asks residents to rate the Authority's performance in areas of maintenance, communication, safety, services, and neighborhood appearance. The Authority receives a rating for each section based on the resident's answers to the survey questions. HUD requires the Authority to develop a Follow-Up Plan for any section in which the rating falls below 75%. The Follow-Up Plan addresses how the Authority intends to increase resident's satisfaction in those areas. The table below includes the results of the last two surveys.

## **Attachment G**

### **Violence Against Women Act**

The Metter Housing Authority is striving to fully comply with all requirements of the Violence Against Women Act (VAWA).

First, the Authority will not deny admission to an applicant who has been a victim of domestic violence, dating violence, or stalking. The applicant must comply with all other admission requirements.

Also, the Authority will not terminate the assistance to a victim of domestic violence, dating violence, or stalking based solely on an incident or threat of such activity. The Authority still retains the right to terminate assistance for other criminal activity or good cause.

All information provided by an applicant or tenant regarding VAWA will be held in strict confidence and will not be shared with any other parties, unless required by law.

Currently, the Housing Authority gives an admissions preference to victims of domestic violence. This preference allows victims of domestic violence to receive housing quicker than they normally would without the preference.

To make sure all applicants are aware of the Violence Against Women Act, the Housing Authority notifies all applicants of the information included in the Act during the application process.
