## Attachment A

### HOUSING AUTHORITY OF CHRISTIAN COUNTY

#### DECONCENTRATION POLICY

##### **PUBLIC HOUSING:**

In an ongoing effort for the Housing Authority to meet or exceed the laws and regulations regarding its public housing programs, the following Deconcentration Policy has been developed in order to comply with the Quality Housing and Work Responsibility Act of 1998, Section 513.

**INCOME MIX TARGETING:** To meet the requirements of the Act and subsequent HUD regulations, at least 40 percent of families admitted to public housing by the Housing Authority must have incomes that do not exceed 30% of the area median. If 40% or more of the Housing Authority units are occupied by families whose incomes do not exceed 30% of the area median income, this requirement shall be considered as being met.

Additionally, to meet this goal, the housing authority may use the provisions of fungibility to the extent that the housing authority has provided more than seventy-five percent of newly available vouchers and certificates in its Section 8 program, including those resulting from turnover, to very poor families. The number of fungible housing credits used to drop the annual requirement for housing very poor families below 40 percent of the newly available units in public housing is limited to the lowest of the following:

1. The number of units equivalent to ten (10) percent of the number of newly available vouchers and certificates in that fiscal year; or,
2. The number of public housing units that (i) are in public housing projects located in census tracts having a poverty rate of 30% or more, and (ii) are made available for occupancy by, and actually occupied in that year by families other than very poor families, or
3. The number of units that cause the housing authority's overall requirement for housing very poor families to drop to 30% of its' newly available units.

**PROHIBITION OF CONCENTRATION OF LOW-INCOME FAMILIES:** The Housing Authority will not, in meeting this income mix targeting, concentrate very low-income families, or other families with relatively low incomes, in public housing units in certain projects or certain buildings, i.e. high-rise, within projects.

## **Attachment A**

The Housing Authority must review the income and occupancy characteristics of the housing projects and the buildings, i.e. high-rise, of each project to ensure that a low-income concentration does not occur.

**DECONCENTRATION:** The Housing Authority will make every effort to deconcentrate families of certain income characteristics within the Public Housing Agency complexes. To achieve this, the Housing Authority may offer incentives for eligible families having higher incomes to occupy dwelling units in projects predominantly occupied by eligible families having lower incomes, and provide for occupancy of eligible families having lower incomes in project predominantly occupied by eligible families having higher incomes. Incentives by the Housing Authority allow for the eligible family to have the sole discretion in determining whether to accept the incentive and the Housing Authority may not take any adverse action toward any eligible family for choosing not to accept these incentives. The skipping of a family on the waiting list to reach another family to implement this Deconcentration Policy shall not be considered an adverse action. As such, the Housing Authority will continue to accept applications and place the individuals on a waiting list. Selection will be made based on a combination of the local preferences and an income target mix. Any eligible family who qualifies as a higher income family may accept a dwelling unit assignment and be placed randomly into a vacant housing unit.

The Housing Authority will track the income mix within each project and building, i.e. high-rise, as an effort to avoid a concentration of higher or lower income families in any one building, i.e. high-rise, or development.

### **SECTION 8 TENANT-BASED ASSISTANCE:**

**INCOME MIX TARGETING:** In each fiscal year, not less than 75% of the new admissions must have incomes at or below 30% of the area median income.

## ATTACHMENT E

### COMMUNITY SERVICE AND SELF-SUFFICIENCY POLICY

#### A. Background

The Quality Housing and Work Responsibility Act of 1998 requires that all non-exempt (see definitions) public housing adult residents (18 or older) contribute eight (8) hours per month of community service (volunteer work) or participate in eight (8) hours of training, counseling, classes or other activities that help an individual toward self-sufficiency and economic independence. This is a requirement of the public housing lease.

#### B. Definitions

**Community Service** – volunteer work which includes, but is not limited to:

- Work at a local institution, including but not limited to: school, child care center, hospital, hospice, recreation center, senior center, adult day care center, homeless shelter, indigent feeding program, cooperative food bank, etc.
- Work with a nonprofit organization such as: Parks and Recreation, United Way, Red Cross, Volunteers of America, Boy Scouts, Girl Scouts, Boys or Girls Clubs, 4-H Program, PAL, Garden Center, community clean-up programs, beautification programs, other counseling, aid, youth or senior organizations
- Helping neighborhood groups with special projects
- Serving as an officer in a resident organization
- Serving on the Resident Advisory Board
- Caring for children of other residents so they may volunteer

**NOTE:** Political activity is excluded.

**Self-Sufficiency Activities** – activities that include, but are not limited to:

- Job readiness programs
- Job training programs
- GED classes
- Substance abuse or mental health counseling
- English proficiency or literacy (reading) classes
- Apprenticeships
- Budgeting and credit counseling
- Any kind of class that helps a person toward economic independence
- Student status at any school, college or vocation school

**Exempt Adult** – an adult member of the family who meets any of the following criteria:

- Is 62 years of age or older
- Is blind or a person with disabilities (as defined under section 216[i][I] or 1614 of the Social Security Act), and who certifies that because of this disability he or she is unable to comply with the service provisions, or is the primary caretaker of such an individual

## ATTACHMENT E

- Is working at least 30 hours per week
- Meets the requirements for being exempted from having to engage in a work activity under TANF or any other State welfare program including a State-administered welfare-to-work program
- Is a member of a family receiving assistance, benefits or services under TANF or any other State welfare program and has not been found to be in noncompliance with such program

### **C. Requirements of the Program**

1. The eight (8) hours per month may be either volunteer work or self-sufficiency program activity, or a combination of the two.
2. At least eight (8) hours of activity must be performed each month. An individual may not skip a month and then double up the following month, unless special circumstances warrant special consideration. The housing authority will make the determination of whether to allow or disallow a deviation from the schedule based on a family's written request.
3. Family obligation:
  - At lease execution, all adult members (18 or older) of a public housing resident family must:
    - Sign a certification that they have received and read this policy and understand that if they are not exempt, failure to comply with the community service requirement will result in a nonrenewal of their lease; and
    - Declare if they are exempt. If exempt, they must complete the Exemption Form and provide documentation of the exemption.
  - Upon written notice from the PHA, non-exempt family members must present complete documentation of activities performed during the applicable lease term. This documentation will include places for signatures of supervisors, instructors, or counselors, certifying to the number of hours contributed.
  - If a family member is found to be noncompliant at the end of the 12-month lease term, he or she, and the head of household, will be required to sign an agreement with the housing authority to make up the deficient hours over the next twelve (12) month period, as a condition of continued occupancy.
4. Change in exempt status:
  - If, during the twelve (12) month lease period, a non-exempt person becomes exempt, it is his or her responsibility to report this to the PHA and provide documentation of exempt status.
  - If, during the twelve (12) month lease period, an exempt person becomes non-exempt, it is his or her responsibility to report this to the PHA. Upon receipt of this information the PHA will provide the person with the appropriate documentation form(s) and a list of agencies in the community that provide volunteer and/or training opportunities.

## ATTACHMENT E

### **D. Authority Obligation**

1. To the greatest extent possible and practicable, the PHA will:
  - Provide names and contacts at agencies that can provide opportunities for residents, including residents with disabilities, to fulfill their community service obligations.
  - Provide in-house opportunities for volunteer work or self-sufficiency activities.
2. The PHA will provide the family with a copy of this policy, and all applicable exemption verification forms and community service documentation forms, at lease-up, lease renewal, when a family member becomes subject to the community service requirement during the lease term, and at any time upon the family's request.
3. Although exempt family members will be required to submit documentation to support their exemption, the PHA will verify the exemption status in accordance with its verification policies. The PHA will make the final determination as to whether or not a family member is exempt from the community service requirement. Residents may use the PHA's grievance procedure if they disagree with the PHA's determination.
4. Noncompliance of family member:
  - At least thirty (30) days prior to the end of the 12-month lease term, the PHA will begin reviewing the exempt or non-exempt status and compliance of family members;
  - If, at the end of the initial 12-month lease term under which a family member is subject to the community service requirement, the PHA finds the family member to be noncompliant, the PHA will not renew the lease unless:
    - The head of household and any other noncompliant resident enter into a written agreement with the PHA, to make up the deficient hours over the next twelve (12) month period; or
    - The family provides written documentation satisfactory to the PHA that the noncompliant family member no longer resides in the unit.
  - If, at the end of the next 12-month lease term, the family member is still not compliant, a 30-day notice to terminate the lease will be issued and the entire family will have to vacate, unless the family provides written documentation satisfactory to the PHA that the noncompliant family member no longer resides in the unit;
  - The family may use the PHA's grievance procedure to dispute the lease termination.



**Attachment F**

**PET POLICY - LEASE ADDENDUM**

This Statement of Pet Policy is established for the Housing Authority of Christian County (HACC) on

\_\_\_\_\_.

Per the requirements of Section 526 of the Quality Housing and Work Responsibility Act of 1998, “a resident of a dwelling unit in public housing may own one (1) or more common household pets or have one (1) or more common household pets present in the dwelling unit of such resident, subject to the reasonable requirements of the public housing agency, if the resident maintains each pet responsibly and in accordance with applicable state and local public health, animal control and animal anti-cruelty laws and regulations and with the policies established in the public housing agency plan for the agency”.

1.0 Application for Pet Permit

Prior to housing any pet on the premises, the resident shall apply to HACC for a pet permit, which shall be accompanied by the following:

- 1.1 A current license issued by the appropriate authority, if applicable; and
- 1.2 Evidence that the pet has been spayed or neutered, as applicable; and
- 1.3 Evidence that the pet has received current rabies and distemper inoculations or boosters, as applicable, and
- 1.4 Evidence of payment of a \$300 pet damage deposit. This deposit must be paid in addition to HACC standard security deposit.

2.0 All residents with pets shall comply with the following rules:

- 2.1 Permitted pets are domesticated dog, cat, hamster, gerbil, birds, and fish aquariums. The weight of the dog or cat may not exceed thirty (30) pounds (adult size).
- 2.2 Only one pet; such as dog, cat, hamster or gerbil per household will be permitted. When the pet is fish; two aquariums, no more than 30 gallons, will be permitted and no more than two birds in 1 cage and no more than 2 cages.
- 2.3 Dogs and cats must be licensed yearly, if community ordinance requires it. Residents must show proof of annual rabies and distemper booster inoculations required by state or local law.

- 2.4 Vicious, intimidating and/or dangerous dogs as defined in 510 ILCS 5/15 will not be allowed.
- 2.5 All dogs and cats must be spayed or neutered, as applicable.
- 2.6 Dogs and cats shall remain inside the resident's unit. No animal shall be permitted to be loose in hallways, lobby areas, Laundromats, community rooms, yards or other common areas of the facility.
- 2.7 When taken outside the unit, dogs and cats must be kept on a leash, controlled by an adult.
- 2.8 Birds must be confined to a cage at all times.
- 2.9 Residents shall not permit their pet to disturb, interfere, or diminish the peaceful enjoyment of other residents. The terms, "disturb, interfere or diminish" shall include but not be limited to barking, howling, chirping, biting, scratching and other like activities.
- 2.10 Residents must provide litter boxes for cat waste, which must be kept in the dwelling unit. Residents shall not permit refuse from litter boxes to accumulate nor to become unsightly or unsanitary.
- 2.11 Residents are solely responsible for cleaning up pet droppings, if any, outside the unit and on facility grounds. Droppings must be disposed of by being placed in a sack and then placed in a refuse container outside the building.
- 2.12 Residents shall take adequate precautions and measures necessary to eliminate pet odors within or around the unit and shall maintain the unit in a sanitary condition at all times.
- 2.13 If pets are left unattended for a period of twenty-four (24) hours or more, HACC may enter the dwelling unit, remove the pet and transfer it to the proper authorities, subject to the provision of state law and pertinent local ordinances. HACC accepts no responsibility for the animal under such circumstances.
- 2.14 Residents shall not alter their unit, patio or unit area in order to create an enclosure for any pet.
- 2.15 Residents are responsible for all damages caused by their pets, including the cost of cleaning of carpets and/or fumigation of units.
- 2.16 Residents are prohibited from feeding or harboring stray animals. The feeding of any stray animals shall constitute having a pet without written permission of the Authority.

- 2.17 Residents that have any dog or cat on the premises and not on the leash for a period of time, more than 10 days, is subject to this policy.
- 2.18 Residents must identify an alternate custodian for pets in the event of resident illness or other absence from the dwelling unit. The identification of an alternate custodian must occur prior to the Authority issuing a pet registration permit.
- 2.19 It is recommended that visitors not bring pets and residents will not engage in “pet-sitting.”
- 2.20 No animals shall be tied up on the outside or left unattended. No doghouses, animal runs, etc., will be permitted.
- 2.21 These rules may be amended from time to time, as necessary, by HACC and such amendments shall be binding on the residents upon notice thereof.
- 2.22 Tenant must herein designate the name of a family member or responsible adult to take responsibility for the pet should said tenant become **incapacitated**.

- 2.23 A pet deposit of \$300.00 will be required for cats, dogs, hamster or gerbil. No deposit is required for birds or fish. If tenant/applicant is financially unable to pay deposit in full, a minimum down payment of \$50.00 is required at time of application, with a monthly payment of \$10.00 until the full deposit of \$300.00 is paid. Deposit is refundable, without interest, at the end of a tenancy.

- 3.0 Residents who violate these rules are subject to: 1) being required to get rid of the pet within 14 days of written notice by HACC; and/or 2) eviction.
- 4.0 The privilege of maintaining a pet in a facility owned and/or operated by HACC shall be subject to the rules set forth above. This privilege may be revoked at any time, subject to HACC Hearing Procedures, if the animal should become destructive, create a nuisance,

represent a threat to the safety, health and security of other residents, or create a problem in the area of cleanliness and sanitation.

- 5.0 A breach of any of the foregoing rules constitutes a breach of the resident's lease and can result in not only in the revocation of the privilege of keeping a pet, but may result in any of the sanctions set forth in the resident's lease for breach thereof, including forfeiture of further leasehold rights and termination of the lease. Further, the resident is subject to the Animal Control Act, Section 351 et. seq. of Chapter 8 of the Illinois Revised Statutes. The election of a remedy by HACC for a resident's breach of the forgoing rules is not exclusive and HACC may thereafter pursue any of the various remedies set forth in the lease as HACC may, in its discretion, decide.

This addendum is valid only for the above-described pet. This addendum must be renewed upon expiration with the resubmission of all required documents. Should the required documents expire prior to the expiration of this agreement, the tenant is required to provide management with proof that renewal has been made. Failure to provide this information is cause to terminate this agreement and may cause action to be initiated to remove pet from unit.

Because the supply of tenant-based units is limited in the county, the Housing Authority of Christian County solicited applications for Section 8 Project-Based Assistance in July 2005.

The Authority attached project-based Section 8 assistance to four units in Vandever Homes, which is located in Taylorville, Illinois. The Low Income Housing Tax Credit project consists of 19 single-family homes. The assistance was made available for 2 two-bedroom units and 2 three-bedroom units. The construction of the project was completed and leasing began in June 2006.

The Authority plans to solicit applications for four to six project based vouchers in the 2007 Fiscal Year.

HACC will aggressively work to decrease the number of vacant units. In an effort to make the Authority more accessible to the population in our rural county, a second office will be opened in Taylorville in July 2007.

The conversion to Asset Management is well underway. Office and maintenance staff has been assigned to either the Pana AMP or Taylorville AMP. We are making a strong effort to control operating costs. The staff will decrease from 14 full-time employees to 11 full-time employees by October 1, 2007. Two part-time positions will be created.

We will concentrate the use of our Capital Funds on our three high rise buildings: Hershey Towers, Pana Towers and Senior Village. An Energy Audit will be conducted on these buildings.

The HACC will continue to create affordable housing and pursue management and maintenance of other housing properties in an effort to provide the Authority with additional sources of income.

The HACC is in the process of revising our Replacement Housing Factor Fund Plan from developing units for sale under the Section 32 Homeownership Plan to developing public housing rental units.

We plan to construct 2 and 3 bedroom town homes in Taylorville with tax credits. The Low Income Housing Tax Credit application may include financing through HOME funds and Trust funds. This development may also include 6 Project-Based Vouchers. The HACC is the Managing Agent for Christian County Integrated Community Services, a 501-(c)-3 Organization. CCICS will develop the tax credit property.

CCICS also has a 46 unit Independent Living Facility under construction in Taylorville. An application with the Illinois Department of Healthcare and Family Services will be made to become a Supportive Living Facility when the moratorium is lifted by the governor.

The Housing Authority of Shelby County has applied with IHDA for 35 single family detached homes under the LIHTC Program. We plan to enter into a Management Agreement with Shelby County to provide management and maintenance services.

We plan to apply for the ROSS Grant for the Elderly and Disabled. This program was very popular with our residents in the past, and at our Public Hearing it was requested that we apply again.

The Authority also plans to apply with the Illinois Housing Development Authority to become a Local Administering Agency with the Rental Housing Support Program. This application will include serving our county and the neighboring counties of Shelby and Montgomery.

The ACOP and Section 8 Administrative Plan are under revision to include the provision that a resident or applicant that is or has been a victim of domestic violence, dating violence, or stalking will not be denied housing or admission to housing if the resident or applicant is otherwise qualified for housing assistance or admission.

During 2006 the Authority installed carbon monoxide detectors in all the appropriate areas as recommended by our insurance carrier, AHRMA.
