ii. Executive Summary of the Annual PHA Plan

The Housing Authority of the City of Richmond is a medium PHMAP Standard-Performer agency located in Wayne County, Indiana. The HACR manages 303 units of public housing in four developments.

The mission of the HACR is:

To promote adequate and affordable housing, economic opportunity and a suitable living environment without discrimination for low-income, very low-income families, persons with disabilities or the elderly.

The HACR will accomplish its mission ideals through its goals and objectives:

- A. Providing decent, safe and affordable housing in your community.
- B. Ensuring equal opportunity in housing for everyone.
- C. Improving community quality of life and economic vitality.
- D. Increase resident participation through resident council and/or advisory committee.
- E. To provide timely response to resident request for maintenance problems.
- F. To return vacated units with new residents in 20 days.
- G. To continue to enforce our "One Strike" policies for residents and applicants.
- H. To improve and/or maintain our financial stability through aggressive rent collections and improved reserve position.
- I. To increase housing stock through new construction, purchase/rehabs and joint ventures with other agencies/businesses.

The HACR's financial resources include an operating fund, capital fund, dwelling rental income and Section 8 Administrative fees which will be used to operate the agency in the most cost effective means possible and still provide the services and activities for its residents.

The HACR has assessed the housing needs of Richmond and surrounding Wayne County area and has determined that it is currently and will continue to meet the housing needs of the community to the extent practical for a medium sized agency. The HACR has approved a Deconcentration Policy and will utilize Local Preferences to

attract and encourage applicants that can qualify for public housing. The HACR has determined that its housing strategy complies with the city of Richmond's Consolidated Plan.

The HACR has updated and rewritten its Admissions and Continued Occupancy Plan, Dwelling Lease and Grievance procedures to comply with all QHWRA requirements. The HACR has established a minimum rent of \$25.00 and elected to recognize its flat and ceiling rents as synonymous and chosen to select the local Fair Market Rents (FMR) to determine its dollar value.

The HACR has conducted a physical needs assessment to determine its modernization requirements and has developed an Annual and 5 year Action Plan to address its Capital Improvements.

The HACR has no plans to demolish or dispose of any of its properties. Nor to convert any of it's public housing units to Section 8 Vouchers. However, it does have an existing program in place.

The HACR has identified compliance with the Community Service requirements by rewriting its Admission and Continued Occupancy Plan and Dwelling Lease to address those adult members of any family whom must perform community service activities annually. In addition, the HACR has developed a self certification form that is enclosed. However the HACR has suspended community service requirements for FY 02 per HUD notification.

The HACR has jointly addressed with the local police department to develop safety and crime prevention that adequately meets the needs of its residents.

The HACR has developed an agency wide Pet Policy that allows any family to have a pet if they follow a set of rules.

The HACR has certified that it has and will continue to adhere to all Civil Rights requirements and will affirmatively further fair housing. In addition, the HACR has included a copy of its most recent fiscal year audit reports as part of the documentation made available for public review during the 45 days prior to submission of HACR's Agency Plan to HUD on April 17, 2007.

The HACR has developed a very effective Asset Management plan to maintain its properties and manage its operation through the proper utilization of the following Annual Plan components:

ADDENDUM # 4

Deconcentration Rule

1. Objective – The objective of the Deconcentration Rule for public housing units is to ensure that families are housed in a manner that will prevent a concentration of higher income families in any one development. The specific objective of the housing authority is to house no less than 40% of its inventory with families that have income at or below 30% of the area median income by public housing development. Also the PHA will take actions to insure that no individual development has a concentration of higher income families in one or more of the developments. To insure that the PHA does not concentrate families with higher income levels, it is the goal of the PHA not to house more than 60% of its units in any one development with families whose income exceeds 30% of the area median income. The PHA will track the status of family income, by development, on a monthly basis by utilizing income reports generated by the PHA.
2. Actions - To accomplish the deconcentration goals, the housing authority will take the following actions:
 - A. At the beginning of each fiscal year, the housing authority will establish a goal for housing 40% of its new admissions with families whose incomes are at or below the area median income. The annual goal will be calculated by taking 40% of the total number of move-ins from the previous fiscal year.
 - B. To accomplish the goals of:

Housing not less than 40% of its inventory on an annual basis with families that have incomes at or below 30% of area median income, and

Not housing families with incomes that exceed 30% of the area median income in developments that have 60% or more of the total household living the development with incomes that exceed 30% of the area median income, the housing authority's Tenant Selection and Assignment Plan, which is a part of this policy, provides for skipping families on the waiting list to accomplish these goals.

ADDENDUM # 5

Deconcentration Rule

Objective – The specific objective of the housing authority is to house no less than 75 percent of its Section 8 inventory with families that have income at or below 30 percent of the area median income. 2. Actions - To accomplish the deconcentration goals, the housing authority will take the following actions:
 - A. At the beginning of each fiscal year, the housing authority will establish a goal for housing 75% of its new admissions with families whose incomes are at or below the area median income. The annual goal will be calculated by taking 75% of the total number of move-ins from the previous fiscal year.
 - B. To accomplish the goals of:
 1. Housing not less than 75% of its inventory on an annual basis with families that have incomes at or below 30% of area median income, and
 2. The housing authority's Tenant Selection and Assignment Plan, which is a part of this policy, provides for skipping families on the waiting list to accomplish these goals.



The PHA has been able to maintain its mission to promote adequate and affordable housing, economic opportunity and a suitable living environment free from discrimination through the utilization of previous Capital funds and the proper application of our public housing policies.

We are continuing to address public housing vacancies very aggressively and our PHAS scores indicate that other operational issues are being positively addressed.

Capital funds have been utilized to provide modernization of our property and our FY 2007 application will continue that effort.

PHA has implemented local preferences to improve the living environment in addition to our modernization efforts

The implementation of a family pet policy has provided the opportunity for residents to enjoy pets within a regulated environment. The Housing Authority of the City of Richmond's policy is designed to identify which adult family members are subject to or exempt from the service requirements; to explain how the PHA will administer its program; to identify PHA and/or third party certification opportunities available to eligible adult family members; and to assure resident compliance with identified work activities with fair and equitable actions.

PHA Responsibilities

(1) Eligibility Determination

The PHA will review every existing resident file to determine each Adult member's status regarding community service per the following guidelines.

- a. As family status is determined a registered letter or other certifiable document of receipt will be sent to each adult member of that family to notify them of their status (exempt or non-exempt) and explaining the steps they should immediately proceed with through their housing representative.
- b. The PHA will include a copy of the general information section of its Community Service Policy and a listing of PHA and/or third party work activities that are eligible for certification of the community service requirement.
- c. At the scheduled meeting with each non-exempt adult family member, not only will the parameters of the community service requirement be reviewed but also the PHA and/or third party work activities will be identified and selected for compliance with the annual obligation for certification at their annual lease renewal date.

(2) Work Activity Opportunities

The Housing Authority of the City of Richmond has elected to provide to those adult family members that must perform community service activities the opportunity to select either PHA sanctioned work activities or Third Party certifiable work items. The administration of the certification process would be:

a. PHA Provided Activities.

When qualifying activities are provided by the Authority directly, designated Authority employee(s) shall provide signed certification that the family member has performed the proper number of hours for the selected service activities.

b. Third Party Certification

When qualifying activities are administered by any organization other than PHA, the family member must provide signed certification (see III A ©) to the Authority by such third party organization that said family member has performed appropriate service activities for the required hours.

Attachment K: Implementation of Public Housing Resident Community Service Requirement

c. Verification of Compliance.

The Authority is required to review family compliance with service requirement, and must verify such compliance annually at least thirty (30) days before the end of the twelve (12) month lease term (annual re-certification time). Evidence of service performance and/or exemption must be maintained in the participant files.

d. Notice of Noncompliance.

If the Authority determines that, a family member who is subject to fulfilling a service requirement, but who has violated the family's obligation (a noncompliant resident) the Authority must notify the specific family member of this determination.

The Notice of Noncompliance must:

1. Briefly, describe the noncompliance (inadequate number of hours).
2. State that the Authority will not renew the lease at the end of the twelve (12) month lease term unless:

The resident or any other noncompliant adult family member enters into a written agreement with the Authority to cure the noncompliance and in fact perform to the letter of agreement.

- Or -

The family provides written assurance satisfactory, to the PHA that the resident or other noncompliant adult family member no longer resides in the unit.

This Notice of Noncompliance must also state that the resident may request a grievance hearing and that the resident may exercise any available judicial remedy to seek timely redress for the Authority's non-renewal of the lease because of a noncompliance determination.

e. Resident agreement to comply with the service requirement.

The written agreement entered into with the Authority to cure the service requirement noncompliance by the resident and any other adult family member must:

1. Agree to complete additional service hours needed to make up the total number of hours required over the twelve (12) month term of the new lease.
2. State that all other members of the family subject to the service requirement are in current compliance with the service requirement or are no longer residing in the unit.

f. The Housing Authority of the City of Richmond has developed a list of Agency certifiable and/or third party work activities of which each non-exempt adult family member can select to perform their individual service requirement.
