The Kansas Department of Commerce and Housing is the State Agency that develops and administers the Consolidated Plan for the non-entitlement areas of the State. Implementation of Public Housing Resident Community Service Requirements

The administrative steps that we have taken to implement the Community Service Requirements include the following:

- 1. Development of Written Description of Community Service Requirement:**
Luray Housing Authority has a written developed policy of Community Service Requirements.
- 2. Scheduled Changes in Leases:**
The Housing Authority has made the necessary changes to the lease.
- 3. Written Notification to Residents of Exempt Status to each Adult Family Member:**
The Housing Authority will notify residents at the time of their move-in and/or recertification.
- 5. Programmatic Aspects**
Community service includes performing work or duties in the public benefit that serve to improve the quality of life and/or enhance resident self-sufficiency, and/or increase the self-responsibility of the resident within the community.

An economic self sufficiency program is one that is designed to encourage, assist, train or facilitate the economic independence of participants and their families or to provide work for participants. These programs may include programs for job training, work placement, basic skills training, education, English proficiency, work fare, financial or household management, apprenticeship, and any program necessary to ready a participant to work (such as substance abuse or mental health treatment).

Brief Description of Pet Policy

Luray Housing Authority allows for pet ownership in its development with the written pre-approval of the Housing Authority Board of Commissioners. However pets are only allowed for medical reasons or as a reasonable accommodation for the elderly and persons with disabilities.

The Luray Housing Authority has adopted the following requirements as part of the Pet Policy:

1. Residents are responsible for all damages caused by their pets, including the cost of fumigating or cleaning the unit.
2. In exchange for the right, resident assumes full responsibility and liability for the pet and agrees to hold the Luray Housing Authority harmless from claims caused by an action or inaction of the pet.
3. Residents must have a prior written approval of the Luray Housing Authority before moving a pet into their unit.
4. Resident must request approval on the Authorization for Pet Ownership Form that must be fully completed before the Housing Authority will approve the request.
5. Resident must give the Luray Housing Authority a picture of the pet so it can be identified if it is running loose.
6. A pet deposit of \$150.00 is required at the time of registering a pet.
7. Resident may not have a pet that weighs more than 20 pounds.
8. Resident is responsible for cleaning any dropping up deposited by their pet.
9. No pet is to be left unattended running loose in the apartment more than 2 hours at any given time.
10. If the pet is aggressive or a nuisance to other tenants, the animal will have to be removed for the safety of others.
11. All dogs and cats must be spayed or neutered before they become six months old. A licensed veterinarian must verify this fact.
12. Only one pet per unit will be allowed.

Violence Against Women Act Report

The Housing Authority of the City of Luray provides or offers the following activities, services, or programs, either directly or in partnership with other service providers, to child or adult victims of domestic violence, dating violence, sexual assault, or stalking.

Through cooperation with the local domestic violence agency and the City of Russell Police Department, any cases of violence as described are referred for assistance. The local domestic violence agency is Northwest Kansas Family Shelter, located in Hays, Kansas.

The Housing Authority of the City of Luray provides or offers the following activities, services, or programs that help child and adult victims of domestic violence, dating violence, sexual assault, or stalking, to obtain or maintain housing.

The local domestic violence agency's program staff is aware of our housing programs, and makes client referrals to our office. Apparently eligible clients are placed on our waiting list.

For persons already living in a Housing Authority unit who become victims as described, these are referred to police and the local domestic violence agency for assistance. If the management becomes aware of any violator who may be restricted through an order of protection, that person is prohibited from the premises and is considered a trespasser subject to arrest and removal. The Police Department is cooperative and supportive in cases such as this, and willingly responds and enforces the protective orders.

The Housing Authority of the City of Luray provides or offers the following activities, services, or programs to prevent domestic violence, dating violence, sexual assault, and stalking, or to enhance victim safety in assisted families.

The same methods as described herein, making referrals to the local domestic violence agency for counseling and support services, and attempting to enforce orders of protection with the cooperation of Police Department personnel, are used.
