Attachment A: Explanation regarding merging public housing units

Due to lack of demand for efficiency apartments, Sanford Housing Authority has merged adjacent pairs of such units into single one-bedroom units. As approved in the 2004 and 2005 Agency Plans, the Sanford Housing Authority has merged efficiency apartments number 608 and number 610 in Sunset Towers (ME36-011/002) into a one-bedroom apartment, using funds from CFP 2002 and CFP 2003. No resident displacement has occurred or will occur due to these changes, as all efficiencies involved were vacant for some time before reconfiguration. All new units are in compliance with Section 504 and all other relevant requirements.
