Replacement Reserve Costs

The Monroe Housing Commission, beginning with its 50105 Capital Fund Program, intends to fund a replacement reserve to carry out eligible capital improvement activities in future years.

The Monroe Housing Commission is negotiating with the City of Monroe for some city-owned property adjacent to the Commission's family project, Greenwood Park Townhouses. Once the property is purchased, the Commission will set aside its replacement reserves for the next several years for the future demolition of the old project and the construction of replacement units. Should negotiations fail between the Housing Commission and the City, the Housing Commission would utilize existing space at its family project to accomplish the same goal.

Annual Capital Fund Program funds are not needed for current needs, since all work items identified in both the Physical Needs Assessment and the most recent Energy Audit have been completed.

ATTACHMENT G

VIOLENCE AGAINST WOMEN ACT (VAWA)

Domestic Violence, Dating Violence, Sexual Assault, Stalking

The Monroe Housing Commission (MHC) has adopted a policy (the “MHC VAWA Policy”) to implement applicable provisions of the Violence Against Women and Department of Justice Reauthorization Act of 2005 (Pub. L. 109-162) (VAWA). MHC’s goals, objectives and policies to enable MHC to serve the needs of child and adult victims of domestic violence, dating violence and stalking, as defined in VAWA, are stated in the MHC VAWA Policy, a copy of which is attached to this Plan by reference.

In addition:

A. The following activities, services, or programs are provided by MHC, directly or in partnership with other service providers, to child and adult victims of domestic violence, dating violence, sexual assault or stalking.

Referral to appropriate agencies, including: local law enforcement, child and family services, domestic violence shelters, the rape crisis program and the Department of Human Services.

B. The following activities, services, or programs are provided by MHC to help child and adult victims of domestic violence, dating violence, sexual assault, or stalking maintain housing.

Victims of domestic violence are given special admission preference.

C. The following activities, services, or programs are provided by MHC to prevent domestic violence, dating violence, sexual assault and stalking, or to enhance victim safety in assisted families.

1. MHC security will assist local law enforcement by reporting, confirming, and investigating instances of abuse.
2. MHC will work with local law enforcement to place perpetrators on a trespassing list and will prosecute violators.
