Needs of Public Housing

Low cost rental housing is provided through a variety of means. There are seven Public Housing commissions in Macomb County, assisting a combined portfolio of roughly 1,300 households. Six of them, listed below, are located within the jurisdiction of the Urban County or the Macomb HOME Consortium:

In addition, MSHDA provided 900 Section 8 Vouchers in Macomb County in 2005. There are, moreover, an undetermined number of families with Vouchers issued by housing commissions outside Macomb County, and who have exercised Voucher portability to obtain housing within the County. The 5 Year Agency Plans (attached to the Consolidated Plan) from these Agencies emphasize preservation and maintenance of existing units.

The County lacks sufficient resources to help any of the Macomb County housing commissions with repair and modernization of their units. There are no troubled public housing commissions in the Urban County, as defined by HUD's Office of Public and Indian Housing. None of the housing commissions within jurisdiction of the Urban County are undertaking resident initiatives.

Although there is no County housing commission, the existing network of housing commissions and privately owned affordable rental developments, has proven effective in providing decent and affordable housing for LI renter households.
