Note* Unit Remodeling under **Dwelling Structure** includes the following: Continue A/C Project and repairs, ceiling fans, lighting & needed repairs, replacement fixtures, install (GFCI's) ground fault circuit interrupters in bathrooms, replacement of Storm Doors, Interior Doors, Entry Doors, locks and door knobs, door bells, mini-blinds, vertical blinds, (replacement or repairs), windows replacements, window screens and repairs as needed, carpet and installation, floor tile and installation or floor restoration, paint, paint prep and application, vanities, sinks, faucets & replacement parts, toilets /handicap toilets & replacement parts, tubs, handheld showers, replacement glass shower doors, shower tile repairs, bathroom hardware, bathroom exhaust fans & replacement motors, attic ventilation, insulation, Brick wing and brick wall repairs, gutters and downspouts and installation. Most will be applied on an as needed basis.
