**The projected work items listed on current Capital Fund Grants and the Capital Fund Program Five-Year Action Plan will be done on an as needed basis and prioritized according to the amounts received in future Capital Fund Grants. Continuing work items include, by account:

***1450 Site Improvement** – Patio, sidewalk, parking lot cement repair/replacement, landscaping, edging, rock, tree maintenance, sprinkler system upgrades and repairs, laundry area fence, dumpster area enclosure/fence, re-seeding lawn areas, painting, handrails, etc.

***1460 Dwelling Structures** – Carpet, Tile flooring and installations, paint, supplies and application, ceiling fans, lighting, extra kitchen outlets, closet doors, entry doors, interior doors, handles and locks, emergency call system upgrade, drapes, curtains, blinds, traverse rods, sinks, faucets, toilets, shower heads, shower valves, handheld shower attachments, shower floor rehab/repair, shower doors, bathroom exhaust fans/lights, smoke alarms, thermostats, wall-mount air conditioner unit replacements, bathroom vanities/shelves, hot water heaters, boiler parts & supplies, gutters, downspouts, brick repair/sealing, water line filters, water shut-offs in boiler rooms, water faucet repair/replacement on outside of buildings, stove exhaust hoods, stove exhaust hoods fire prevention attachments, fire extinguishers, window screen replacement/repairs, window handles, security system, energy-saving fluorescent bulbs etc.

***1465.1 Dwelling Equipment** – Stoves, refrigerators, etc.

***1470 Nondwelling Structures** – Gutters, downspouts, furnace and air conditioner replacement, update handicap accessible entry door, carpet, vinyl/tile flooring and installation, paint, supplies and application, patio cover, energy efficient door and windows in community room, maintenance shed roof, bathroom exhaust fans and lights, light fixtures, maintenance room shelving and storage bins, upgrade fire extinguishers, brick repair/sealing, drapes, blinds, rods, laundry room rehab, toilets, sinks, faucets, possible addition on current maintenance shed or new maintenance/storage building, possible carports or parking enclosures, office, community room, lobby, bathroom and maintenance room upgrades, security system, etc.

***1475 Nondwelling Equipment** – Community room equipment and furniture (stove, refrigerator, microwave, TV, chairs, tables, etc.), office furniture, file cabinets, computer, copier, laundry room washers and dryers, maintenance vehicle, commercial mower, snow blowers, patio furniture, miscellaneous maintenance tools and equipment, etc.
