

Mr. Reid opened the meeting at 5:30 p.m. with an introduction of Ms. Helen Albany, Receptionist and Mr. Starling, Director of Development who are both assisting Mr. Reid in the Modernization Department. Sister Mary Margaret inquired about the responsibility of the Development Director. Mr. Reid explained that it is for the development of Housing Improvement and Development. He further explained that Mr. Starling would be assisting with the development of the new 12-2br townhouse style units which will replace the units destroyed by fire in 2000. Mr. Reid reported that bid proposals were advertised and would be opened publicly on Wednesday, November 8, 2006. Some of the residents expressed concerns as to the quality of work that will be done and whether it would better aesthetic finishing. Mr. Starling explained that his experience is to make sure that all projects are done satisfactorily and the outcome is favorable. Mr. Reid reported:

- The large elevator at Comstock Court is being replaced with new equipment and the small elevator will be worked on when the large elevator is completed. He further explained that Mr. John Weldin, Elevator Engineer is the best for elevator work.
- The chimney at Lumley A & B, which was hazardous, will be lined with a stainless steel liner.

- The playground equipment at Boston Way Village and Lincoln Village was demolished and removed.
- The fire alarms and alert systems for all sites are operational.
- The Gable Ends at Lincoln Village were done. The contractors did an excellent job.
- Lincoln Village will have new windows and APHA will be going out to re-bid.
- New exterior doors are to be done-21 doors at Asbury Park Village and 2 doors at Lincoln Village. APV (Asbury Park Village) will be done first because they are the worse.
- APHA passed the REAC Inspection this year, not with the best score but we passed. In some of the areas we failed, it was due to no tub stoppers and the pilot light was out. Mr. McAllister explained that all residents are not always aware that the pilot light is out and suggested that new stoves should be installed.
- Check Meters at Washington Village and Asbury Park Village will be covered. Mr. Reid expressed to the residents to call Management and Maintenance to report problems. If no response, call back again, if no response, call Mr. Smith's Office.
- Range hoods will be installed at Robinson Towers and that would help eliminate the frequency of smoke alarms.
- The tenant election associates will meet with Mr. Smith, Mr. Reid and Ms. Wise to set criteria for the campaign. Mr. Reid emphasized that the residents are to elect their Presidents and Vice Presidents instead of APHA Staff.

Mr. Reid asked for comments from the Council:

Charlotte Wise-Washington Village:

- Reported on the up coming election and explained the By-laws.
- Expressed concerns the tenants' low morale due to the negative attitudes expressed by APHA Staff and Administration.
- Explained that a tenant must be living in Public Housing for over a year in order to run for office/position.
- Washington Village is becoming more and more dangerous for the residents and need help and more security. Especially from the Police.

Doris Anderson Harrell-Asbury Park Village:

- Reported that the trash/garbage is horrendous and the mold needs to be removed from the wall and floor.
- Reported that nothing is being done on the Tenant Association Room.

Mr. Reid-Robinson Towers:

- Reported that work is to be done on the elevators.
- Range Hoods will be installed
- Expressed great concern and asked that the EMERGENCY PULL CORD is not to be tied up but left hanging in case someone falls.
- The residents expressed concerns for an alarm on the rear entrance door because it is constantly being propped open and anyone can enter.

Sister Mary Margaret-Lumley A & B reported:

- That trained security is needed in the family sites as well as the senior sites.
- The need for an alarm on the back entrance door because the door(s) is also being propped open with objects.
- The parking lot is never clean
- The residents have to go out of the building to get to the Social Room and why the Computer Room could not be used for the Social Room.
- To have the parking lot spaces relined.

Mr. McAllister inquired about the "Billy Goat" and where it is kept. Also, whether this is a new equipment or the old one which was purchased some time ago.

The meeting adjourned at 8:00 p.m.

(1) Taking appropriate personnel action against such an employee, up to and including termination, consistent with the requirements of the Rehabilitation Act of 1973, as amended; or

(2) Requiring such employee to participate satisfactorily in a drug abuse assistance or rehabilitation program approved for such purposes by a Federal, State, or local health, law enforcement, or other appropriate agency;

g. Making a good faith effort to continue to maintain a drug-free workplace through implementation of paragraphs a. thru f.



1. The Plan is consistent with the applicable comprehensive housing affordability strategy (or any plan incorporating such strategy) for the jurisdiction in which the PHA is located.
2. The Plan contains a certification by the appropriate State or local officials that the Plan is consistent with the applicable Consolidated Plan, which includes a certification that requires the preparation of an Analysis of Impediments to Fair Housing Choice, for the PHA's jurisdiction and a description of the manner in which the PHA Plan is consistent with the applicable Consolidated Plan.
3. The PHA has established a Resident Advisory Board or Boards, the membership of which represents the residents assisted by the PHA, consulted with this Board or Boards in developing the Plan, and considered the recommendations of the Board or Boards (24 CFR 903.13). The PHA has included in the Plan submission a copy of the recommendations made by the Resident Advisory Board or Boards and a description of the manner in which the Plan addresses these recommendations.
4. The PHA made the proposed Plan and all information relevant to the public hearing available for public inspection at least 45 days before the hearing, published a notice that a hearing would be held and conducted a hearing to discuss the Plan and invited public comment.
5. The PHA will carry out the Plan in conformity with Title VI of the Civil Rights Act of 1964, the Fair Housing Act, section 504 of the Rehabilitation Act of 1973, and title II of the Americans with Disabilities Act of 1990.
6. The PHA will affirmatively further fair housing by examining their programs or proposed programs, identify any impediments to fair housing choice within those programs, address those impediments in a reasonable fashion in view of the resources available and work with local jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement and maintain records reflecting these analyses and actions.
7. For PHA Plan that includes a policy for site based waiting lists:
 - The PHA regularly submits required data to HUD's MTCS in an accurate, complete and timely manner (as specified in PIH Notice 99-2);
 - The system of site-based waiting lists provides for full disclosure to each applicant in the selection of the development in which to reside, including basic information about available sites; and an estimate of the period of time the applicant would likely have to wait to be admitted to units of different sizes and types at each site;
 - Adoption of site-based waiting list would not violate any court order or settlement agreement or be inconsistent with a pending complaint brought by HUD;
 - The PHA shall take reasonable measures to assure that such waiting list is consistent with affirmatively furthering fair housing;


