Progress Statement: *During FY 2006, CMHA has partnered with local banking intuitions to provide resident with credit counseling and budgeting classes. We have a local resource that provides homeownership training and counseling at no cost to our residents. The Life Skills Coordinator meets with residents as needed to instruct them with any home maintenance matters and provides them with video instructions as well as booklets and brochures. We receive various donations from the community to provide residents with household furnishings and personal items as needed.*

The Chillicothe Metropolitan Housing Authority has prepared this Annual PHA Plan in compliance with Section 511 of the Quality Housing and Work Responsibility Act of 1998 and the ensuing HUD requirements.

The purpose of the Annual Plan is to provide a framework for local accountability and an easily identifiable source by which public housing residents, participants in the tenant-based assistance program and other members of the public may locate basic PHA policies, rules and requirements related to the operations, programs and services of the agency.

The Mission Statement and the Goals and Objectives were based on information contained in our jurisdiction's Consolidated Plan and will assure that our residents will receive the best customer service.

Excellent customer service and fulfillment of the Mission Statement and Goals and Objectives is ensured by implementation of a series of policies that are on display with this Plan. The Admissions and Occupancy Policy and Section 8 Administrative Plan are the two primary policies on display. These important documents cover the public housing tenant selection and assignment plan, outreach services, PHA's responsibility to Section 8 owners/landlords, grievance procedures, etc.

The most important challenges to be met by the Chillicothe Metropolitan Housing Authority during FY 2007 include:

- *Identification of management needs to enable PHA staff to prepare for major upcoming changes in the Operating Fund rule, i.e. Project-Based Accounting, Asset Management, Cost Allocation Planning and software upgrades;*

- *Preservation and improvement of the public housing stock through the Capital Funds Program;*
- *Involvement of public housing residents and Section 8 participants, through the Annual PHA Plan Resident Advisory Board;*
- *Training of staff and commissioners in order to fully understand and take advantage of opportunities in new laws and regulations, to better serve our residents and the community;*
- *Identification, development, and leveraging of services and programs to enable low-income families to become self-sufficient and to ultimately become homeowners; and*
- *Regain High Performer Status and maintain high performer with SEMAP.*
- *The CMHA will actively pursue other funding sources to provide additional resident services.*

In closing, this Annual PHA Plan exemplifies the commitment of the Chillicothe Metropolitan Housing Authority to meet the housing needs of the full range of low-income residents. The Chillicothe Metropolitan Housing Authority, in partnership with agencies from all levels of government, the business community, non-profit community groups, and residents will use this plan as a road map to reach the “higher quality of life” destination for the City of Chillicothe and Ross County.

DE-CONCENTRATION AND INCOME TARGETING POLICY
FOR THE
CHILLCOTHE METROPOLITAN HOUSING AUTHORITY
CHILLCOTHE, OHIO

DE-CONCENTRATION AND INCOME TARGETING POLICY
(of the Public Housing Admissions and Occupancy Policy)

Sub-Title A, Section 513 of the Quality Housing and Work Responsibility Act of 1998 (QHWRA), establishes two interrelated requirements for implementation by Public Housing Authorities: (1) Economic De-concentration of public housing developments and (2) Income Targeting to assure that families in the “extremely low” income category are proportionately represented in public housing and that pockets of poverty are reduced or eliminated. In order to implement these new requirements the PHA must promote these provisions as policies and revise their Admission and Occupancy policies and procedures to comply.

Therefore, the Chillicothe Metropolitan Housing Authority, Chillicothe, Ohio (hereinafter referred to as PHA) hereby affirms its commitment to implementation of the two requirements by adopting the following policies:

A. Economic De-concentration:

Admission and Continued Occupancy Policies are revised to include the PHA’s policy of promoting economic de-concentration. Implementation of this program may require the PHA to determine the median income of residents in each development, determine the average income of residents in all developments, compute the Established Income Range (EIR), determine developments outside the EIR, and provide adequate explanations and/or policies as needed to promote economic de-concentration.

Implementation may include one or more of the following options:

- Skipping families on the waiting list based on income;
- Establishing preferences for working families;
- Establish preferences for families in job training programs;
- Establish preferences for families in education or training programs;
- Marketing campaign geared toward targeting income groups for specific developments;
- Additional supportive services;
- Additional amenities for all units;
- Flat rents for developments and unit sizes;
- Different tenant rent percentages per development;
- Different tenant rent percentages per bedroom size;
- Saturday and evening office hours;
- Security Deposit waivers;
- Revised transfer policies;
- Site-based waiting lists;
- Mass Media advertising/Public service announcements; and
- Giveaways.

B. Income Targeting

As public housing dwelling units become available for occupancy, responsible PHA employees will offer units to applicants on the waiting list. In accordance with the Quality Housing and Work Responsibility Act of 1998, the PHA encourages occupancy of its developments by a broad range of families with incomes up to eighty percent (80%) of the median income for the jurisdiction in which the PHA operates. Depending on the availability of applicants with proper demographics, at a minimum, 40% of all new admissions to public housing **on an annual basis** may be families with incomes at or below thirty percent (30%)(extremely low-income) of the area median income. The offer of assistance will be made without discrimination because of race, color, religion, sex, national origin, age, handicap or familial status.

In order to implement the income targeting program, the following policy is adopted:

- The PHA may select, based on date and time of application and preferences, two (2) families in the extremely low-income category and two (2) families from the lower/very low-income category alternately until the forty percent (40%) admission requirement of extremely low-income families is achieved (2 plus 2 policy).
- After the minimum level is reached, all selections may be made based solely on date, time and preferences. Any applicants passed over as a result of implementing this 2 plus 2 policy will retain their place on the waiting list and will be offered a unit in order of their placement on the waiting list.
- To the maximum extent possible, the offers will also be made to affect the PHA's policy of economic de-concentration.
- The PHA reserves the option, at any time, to reduce the targeting requirement for public housing by no more than ten percent (10%), if it increases the target figure for its Section 8 program from the required level of seventy-five percent (75%) of annual new admissions to no more than eighty-five percent (85%) of its annual new admissions. (Optional for PHAs with both Section 8 and Public Housing programs)

COMMUNITY SERVICE DESCRIPTION OF IMPLEMENTATION

Description of the Community Service Policy

The Chillicothe Metropolitan Housing Authority Community Service Policy is simple and definitive of Section 512 of the Quality and Work Responsibility Act of 1998. The Chillicothe Metropolitan Housing Authority believes that the community service requirement should not be received by the resident to be a punitive or demeaning activity, but rather to be a rewarding activity that will benefit both the resident and the community. Community service offers public housing residents and opportunity to contribute to the communities that support them while gaining work experience. The requirement is easy and rewarding and the Housing Authority provides the residents with the name of agencies, the agencies point of contact and all required paper work necessary to accomplish the monthly service.

The Community Service Policy allows the PHA to identify those residents required to participate in the community service requirement. Participants will be required to contribute 8 hours of community service each month or to participate in a self-sufficiency program for 8 hours each month. Identified residents are responsible to determine the appropriateness of the voluntary service within guidelines provide in the policy. Allowed activities that may be included are listed in the policy. Voluntary political activities are prohibited from being considered to meet the Community Service requirement. Participation in self-sufficiency activities that may be included are listed in the policy. A list of exemptions that may be claimed from the requirement is provided in the policy. Family obligations and PHA obligations are addressed in detail. Lease requirements and documentation and non-compliance are all clearly addressed.

All residents are permitted to own and keep common domesticated household pets. Common household pet means a domesticated cat, dog, bird, gerbil, hamster, Guinea pig, and fish in aquariums.

Pet owners must agree to abide by the PHA's Pet Ownership Rules.

The CMHA will not charge a non-refundable pet fee.

A \$300.00 refundable deposit for dogs and cats, and \$25.00 deposit for fish is required. The CMHA shall refund the unused portion of the pet deposit to the pet owner within thirty (30) days after the pet owner moves from the dwelling or no longer owns or keeps a pet in the dwelling unit.

Limit of one pet per household.

Limit for birds is two (2).

Pet owner may have only a small cat or a small dog. Limitations: weight not to exceed twenty (20) pounds; height shall not exceed fifteen (15) inches. *This does not apply to service animals that assist persons with disabilities.*

Pet owner shall license their pet as required by law.

Pet owner must not violate any state or local health or humane laws.

Pet must be spayed or neutered.

Pet must be maintained on leash and kept under control when taken outside the unit.

Description of Homeownership Programs

Section 5 H Plan

This plan provides homeownership opportunities for CMHA residents and other low-income families. The Authority proposes to sell in two phases, up to thirty-three (33) homes located in Chillicothe and Ross County area.

The units will be sold to eligible families through a fee simple conveyance, and eligible homebuyers will have to qualify for a first mortgage from a private mortgage lender. Families will have to qualify for a first mortgage using 35% of their adjusted monthly income for housing costs. The Authority will hold the remainder of the cash price in a promissory note. The family will not be required to pay on the note, as long as the family resides in the home ten (10) years. The note will be secured by a second mortgage on the property, which shall be recorded at the Ross County Recorder's Office. CMHA has partnered with the City of Chillicothe to provide down payment and closing cost assistance to at least six (6) families purchasing homes in Chillicothe under this program.

The Authority will administer a three-tiered training program. The program will allow families in any economic position to participate in the program. CMHA will utilize its Family Self-Sufficiency Program, as well as homebuyer counseling and training, to be administered by the FSS Coordinator. The counseling and training programs are required for each family participating in the program.

Voucher Homeownership Program

Basic concept – Instead of using voucher subsidy to help family with rent, homeownership option allows first-time homeowner to use voucher subsidy to meet monthly homeownership expenses.

The family is responsible for finding eligible unit to purchase instead of rent.

PHA will make monthly homeownership assistance payment on behalf of the new homeowner.

PHA may make payment to lender or directly to the family.

Participant Qualification

A Section 8 Program applicant or participant may utilize their voucher subsidy to purchase, rather than rent a home, subject to the following requirements:

1. A family must meet the general requirements for admission to or continued participation in the CMHA Section 8 Tenant-Based Program.
2. Current Section 8 Program participants must be in full compliance with their lease and Section 8 Program requirements and must terminate their current lease arrangement in compliance with the lease.
3. A head of household or spouse that has previously defaulted on a mortgage obtained through the homeownership option is barred from participation.
4. Program participants must be “first-time homebuyers”, where a family member must not have owned title to a principal residence in the last three (3) years. Residents of limited equity cooperatives are eligible for the homeownership program.
5. Participants in the Section 8 homeownership option must complete a pre-purchase and post-purchase homeownership counseling program and be deemed to be “mortgage ready” before a homeownership voucher will be issued. The CMHA FSS Coordinator will review the applicant’s pre-application and work with the family to determine mortgage readiness.

One or more adult members that will own the home must be employed full-time. Full time employment is defined as working not less than an average of 30 hours per week.

The employment requirement does not apply to an elderly/disabled family.



VAWA Support and Assistance

The Chillicothe Metropolitan Housing Authority has incorporated in its PHA Plan goals and objectives, and policies and procedures the applicable provisions of the Violence Against Women and Reauthorization Act of 2005 (VAWA) to support or assist victims of domestic violence, dating violence, or stalking.

The PHA goal to provide and improved living environment is being met by the PHA by its effort to implement measures to assist victims of domestic violence in avoiding their abusers and continuing occupancy in public housing.

Towards its effort to meet the PHA goal to promote self-sufficiency and asset development of assisted households the PHAs partnering with local agencies to provide or attract supportive services to assist victims of domestic violence move out of abusive situations and begin again. Among these is the Ross County Coalition Against Domestic Violence (RCCADV) who will present and provide access to the Public Housing residents and Section 8 participants the following goals and programs:

- Provide speakers and educators available to make presentations at resident council meetings
- Promote “Domestic Violence Awareness” Program
- Execute a 4-week program for the youth
- Execute a 2-week program at the PHAelderly sites
- Conduct health and safety plans
- Network with Child Protective Center to conduct parenting classes
- Conduct Part A and B annual programs
- Currently drafting a Memorandum of Understanding

In addition, the PHA has amended its policies and procedures to include language and applicable provisions of the VAWA. It is the PHA intent to maintain compliance with all applicable requirements imposed by VAWA.

The PHA efforts may include to:

- Provide and maintain housing opportunities for victims of domestic violence, dating violence, or stalking;
- Create and maintain collaborative partnerships between PHA victim service providers, law enforcement authorities, and other supportive groups to promote the safety and well-being of victims of domestic violence, dating violence, or staking (whether actual or imminent threat) who are assisted by PHA
- Ensure the physical safety of victims of domestic violence, dating violence, or stalking (whether actual or imminent threat) who are assisted by PHA maintain compliance with all applicable requirements imposed by VAWA.

- Take appropriate action in response to an incident or incidents of domestic violence, dating violence, or stalking, affecting families or individuals assisted by PHA.

CMHA shall train its staff on the required confidentiality issues imposed by VAWA.

Finally, the PHA is providing a preference in the Section 8 HCV program for victims of domestic violence.
