4. The PHA will carry out the streamlined Annual Plan in conformity with Title VI of the Civil Rights Act of 1964, the Fair Housing Act, section 504 of the Rehabilitation Act of 1973, and title II of the Americans with Disabilities Act of 1990.
5. The PHA will affirmatively further fair housing by examining their programs or proposed programs, identify any impediments to fair housing choice within those programs, address those impediments in a reasonable fashion in view of the resources available and work with local jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement and maintain records reflecting those analyses and actions.

14. The PHA will provide HUD or the responsible entity any documentation that the Department needs to carry out its review under the National Environmental Policy Act and other related activities in accordance with 24 CFR Part 58.
15. With respect to public housing the PHA will comply with Davis-Bacon or HUD determined wage rate requirements under section 12 of the United States Housing Act of 1937 and the Contract Work Hours and Safety Standards Act.
16. The PHA will keep records in accordance with 24 CFR 85.23 and facilitate an effective audit to determine compliance with program requirements.

Anyone convicted of any type of sexual offense whether subject to lifetime registration requirement under state law or not required to register shall not be admitted to the Housing Choice Voucher Program.

In an effort to exclude “dangerous sex offenders” from the Housing Choice Voucher program, federal law prohibits anyone subject to state sex offense registries from admission or participation at the program. This lifetime exclusion from the program will protect children and other victims from violent, repeat sexual predators. In compliance with this requirement the Municipality will terminate assistance to any household in which a member is convicted for a sexual offense or who is subject to the lifetime registration or has been convicted for a sexual offense or who is subject to the lifetime registration.
