

*Acting on behalf of the Board of Commissioners of the Public Housing Agency (PHA) listed below, as its Chairman or other authorized PHA official if there is no Board of Commissioners, I approve the submission of the streamlined Annual PHA Plan for PHA fiscal year beginning **October 2007**, hereinafter referred to as the Streamlined Annual Plan, of which this document is a part and make the following certifications, agreements with, and assurances to the Department of Housing and Urban Development (HUD) in connection with the submission of the Streamlined Plan and implementation thereof:*

1. The streamlined Annual Plan is consistent with the applicable comprehensive housing affordability strategy (or any streamlined Plan incorporating such strategy) for the jurisdiction in which the PHA is located.
2. The PHA has established a Resident Advisory Board or Boards, the membership of which represents the residents assisted by the PHA, and provided this Board or Boards an opportunity to review and comment on any program and policy changes since submission of the last Annual Plan.
3. The PHA made the proposed streamlined Annual Plan, including policy and program revisions since submission of the last Annual Plan, and all information relevant to the public hearing available for public inspection at least 45 days before the hearing, published a notice that a hearing would be held and conducted a hearing to discuss the streamlined Plan and invited public comment.
4. The PHA will carry out the streamlined Annual Plan in conformity with Title VI of the Civil Rights Act of 1964, the Fair Housing Act, section 504 of the Rehabilitation Act of 1973, and title II of the Americans with Disabilities Act of 1990.
5. The PHA will affirmatively further fair housing by examining their programs or proposed programs, identify any impediments to fair housing choice within those programs, address those impediments in a reasonable fashion in view of the resources available and work with local jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement and maintain records reflecting these analyses and actions.
6. For streamlined Annual Plans that include a policy or change in policy for site-based waiting lists:
The PHA regularly submits required data to HUD's MTCS in an accurate, complete and timely manner (as specified in PIH Notice 99-2);
 - The system of site-based waiting lists provides for full disclosure to each applicant in the selection of the development in which to reside, including basic information about available sites; and an estimate of the period of time the applicant would likely have to wait to be admitted to units of different sizes and types at each site;
 - Adoption of site-based waiting list would not violate any court order or settlement agreement or be inconsistent with a pending complaint brought by HUD;
 - The PHA shall take reasonable measures to assure that such waiting list is consistent with affirmatively furthering fair housing;
 - The PHA provides for review of its site-based waiting list policy to determine if it is consistent with civil rights laws and certifications, as specified in 24 CFR part 903.7(b)(2).
7. The PHA will comply with the prohibitions against discrimination on the basis of age pursuant to the Age Discrimination Act of 1975.
8. The PHA will comply with the Architectural Barriers Act of 1968 and 24 CFR Part 41, Policies and Procedures for the Enforcement of Standards and Requirements for Accessibility by the Physically Handicapped.
9. The PHA will comply with the requirements of section 3 of the Housing and Urban Development Act of 1968, Employment Opportunities for Low-or Very-Low Income Persons, and with its implementing regulation at 24 CFR Part 135.
10. The PHA has submitted with the streamlined Plan a certification with regard to a drug-free workplace required by 24 CFR Part 24, Subpart F.
11. The PHA has submitted with the streamlined Plan a certification with regard to compliance with restrictions on lobbying required by 24 CFR Part 87, together with disclosure forms if required by this Part, and with restrictions on payments to influence Federal Transactions, in accordance with the Byrd Amendment and implementing regulations at 49 CFR Part 24.
12. The PHA will comply with acquisition and relocation requirements of the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 and implementing regulations at 49 CFR Part 24 as applicable.
13. The PHA will take appropriate affirmative action to award contracts to minority and women's business enterprises under 24 CFR 5.105(a).

14. The PHA will provide HUD or the responsible entity any documentation that the Department needs to carry out its review under the National Environmental Policy Act and other related authorities in accordance with 24 CFR Part 58.
15. With respect to public housing the PHA will comply with Davis-Bacon or HUD determined wage rate requirements under section 12 of the United States Housing Act of 1937 and the Contract Work Hours and Safety Standards Act.
16. The PHA will keep records in accordance with 24 CFR 85.20 and facilitate an effective audit to determine compliance with program requirements.
17. The PHA will comply with the Lead-Based Paint Poisoning Prevention Act and 24 CFR Part 35.
18. The PHA will comply with the policies, guidelines, and requirements of OMB Circular No. A-87 (Cost Principles for State, Local and Indian Tribal Governments) and 24 CFR Part 85 (Administrative Requirements for Grants and Cooperative Agreements to State, Local and Federally Recognized Indian Tribal Governments.).

Vicky Powell, a Homebuyer Participant volunteered to take the minutes of the meeting.

Mary Ann Cuellar; reviewed page by page the 2007 Streamlined Annual Plan in conjunction with the 5-Year Agency Plan.

Mary Ann Cuellar started on page two of the TCHAO Annual Plan, noting the Fiscal Year beginning October 2007, that program administered was a Section 8 only which consisted of 2041 Vouchers.

Mary Ann Cuellar explained how HUD initiated the 5-Year Plan and how housing agencies are required to submit an Annual Agency Plan every year.

Under display locations for PHA Plans and supporting documents, Mary Ann advised that the TCHAO Administrative Plan and the TCHAO Annual Plan were available to view at the main office.

In reviewing the Waiting List area of the plan, Mary Ann went over the HUD requirements on how program applicants on the waiting list are contacted and the requirements for the administrative plan policies. She explained that external/internal audits were performed to insure that TCHAO is following the required regulations and policies.

After some discussion, a question was asked on Capital Improvements. Mary Ann advised that Capital Improvements applied only to Public Housing Programs, and Tarrant County did not have a Public Housing Program.

On page 6, Mary Ann discussed the Section 8 Tenant Based Assistance –Section 8 Homeownership Program. She noted that agency marked “yes”, and stated that all program participants are encouraged to participate in the Tarrant County Homebuyer’s Club Program. Mary Ann noted that once you have established self sufficiency and good escrow account, homeownership would be the next step to maintaining self sufficiency.

Mary Ann explained how the TCHAO Homebuyer’s Club program provides education classes on credit issues, financing, real estate, establishing an individual budget for each participant, pulling credit reports and assisting each participants with preparing letters to clean up credit issues and other required subjects to prepare participants to purchase a home, etc.

On page 8, Mary Ann stated that the Consolidated Plan jurisdiction was Tarrant County, and gave a brief description of what the Consolidated Plan consisted of and it’s purpose, etc. She went over the boxes marked under this subject which included TCHAO’s participation in the consultation process.

On page 9, Mary Ann explained the supporting documents available for review for the streamlined annual agency plan. Mary Ann touched up on Fair Housing, how Fair Housing applies to everyone, and how to handle discrimination when renting or buying a house, etc.

Mary Ann explained how the Agency Plan must be approved by a Board/Commissioner Resolution before submitting to HUD.

Other questions centered on individual issues relating to reporting interims, when they can transfer, how to calculate rent, FMR/utility allowance, child support issues and how the laws and regulations for Section 8 are made.

Mr. Wayne Pollard; discussed the Violence Against Women’s Act. Mr. Pollard reported on January 5, 2006, President Bush signed into law the “Violence Against Women and Department of Justice Reauthorized Act of 2005”

Under VAWA, an applicant or participant is or has been a victim of domestic violence, or stalking is not grounds for denial of program assistance or for denial of admission, if the applicant or tenants meets other eligibility requirements.

A tenant may not be evicted, nor may his or her assistance be terminated, based on such an incident or incidents of actual or threatened domestic violence, dating violence, or stalking where the tenant is the victim.

He reported that eviction applies for certain types of criminal activity as provided in the lease, and the housing agency may terminate a household’s assistance in such cases He stated

VAWA protects, directly related to domestic violence, dating violence, or stalking.

He provided the group with copies of the TCHAO Messenger Newsletter that provided more details of VAWA. Mr. Pollard stated this newsletter was mailed to each participant and a landlord's edition was mailed at the same time to all owners participating in the TCHAO program.

Mr. Pollard reminded all to report their change in utility companies before they change as each time an electric utility account number is not correct or inactive, it can hold up the entire utility check from being applied to other tenant accounts.

Barbara Whaley; FSS Coordinator discussed the FSS Program and encouraged those Homebuyer Club participants that have not contracted in the FSS program to get involved. She reminded all that an FSS Recruitment Orientation is conducted was 2 hrs once a month. The next orientation is scheduled for June 21, 2007 @ 5:30 -7:30pm.

Barbara explained that FSS is a 5 year program to promote self sufficiency and Homeownership. She explained the benefits of the program and why everyone should join. She gave an example of how the escrow amount is calculated.

She ended her session by reminding all to join the FSS Program to work on goals and achievements.

Mr. Pollard thanked everyone for attending today's program, and reminded everyone of the Homebuyer Program scheduled for Saturday, June 9, 2007.

PUBLIC HEARING
TARRANT COUNTY HOUSING ASSISTANCE ANNUAL AGENCY PLAN 2007
June 5, 2007

On June 5, 2007 the Tarrant County Commissioners Court held a Public Hearing for the Tarrant County Housing Assistance Office (TCHAO) in reference to the 2007 Annual Agency Plan for FY2007.

Upon opening the floor for public comments, Richard Vickers of 410 West 7th Apt. 306, Ft. Worth, TX 76102 was recognized. He began by stating he was concerned with Fort Worth Housing and that he wants to make sure that Section 8 people were receiving enough to pay their bills as the rates had increased.

Judge Whitley asked Ms. Beasley to respond. She explained how allowances are determined using HUD formula and that the allowance is not designed to cover the full expense for the utility. She explained that TCHAO reviews allowances each year and if the rates have increased or decreased by 10% or more, adjustments are made. She explained that a review had already been completed this year and it was determined that there was not a 10% increase or decrease. She stated that the large increase came in 2006 when there was a 26% increase in rates. She also explained that each Housing Authority is responsible for determining these allowances based on the consumption for the area they service and that TCHAO has nothing to do with Fort Worth.

Once explained how the TCHAO handles the process based on HUD Regulations, Mr. Vickers stated that he had no problem with the way things were being handled in the Tarrant County Housing Office. Mr. Vickers stated that he would like to get with Ms. Beasley to discuss the matter further.

Mrs. Beasley spoke with Mr. Vickers outside of Commissioners Court on June 5, 2007. He advised her that he is not a Section 8 participant with TCHAO and is assisted by the MHMR Gateway Housing Program. Mr. Vickers stated he is on a mission to make sure that Section 8 people are able to pay their bills. Mrs. Beasley asked him what he needed and he requested copies of the utility allowances sheets. Copies were mailed to him for Single, Multi-Family, Manufactured/ Mobile Home and Duplex on June 7 to the address he provided above.
