### **PH Homeownership**

The Community Development Commission of Mendocino County is working on a public housing homeownership plan to sell the remaining single-family units owned by the Commission in Ukiah and the unincorporated area near Ukiah. The Commission has submitted preliminary information to the HUD special projects office in Chicago and the local field office. The plan was included in the Agency Annual Plan for 2004 that was submitted to and approved by HUD.

The Community Development Commission of Mendocino County will conduct an analysis of public housing and funding due to chronic operating loss for those units. This analysis and subsequent action may include the conversion (disposition) of public housing units to voucher units.
