 other (describe below:) Housing Authority has more extreme low-income near-elderly/elderly and disabled singles who are referred to us due to substandard housing; homeless or at risk of homelessness than we can house. Local Elderly units are full with waiting list. S-8 Voucher wait-list is one year long and does not respond to emergency needs often evident in elderly/disabled populations. A secondary issue relates to local housing rejecting “at-risk” populations of hard to house and disabled applicants in their apartment units. Special needs are seen as a drain on management activities. The Authority intends to seek project basing in Authority owned 1 bedroom units. These units are Elderly/disable units funded with CDBG funds, which have now passed their affordability period. Because of the shortage in housing for special populations, we have been renting at below our costs. We can no longer provide this service and will transform these units to market rent unless rental support is available. Loss of this housing will have a significant impact on the community.




