ii. Executive Summary of the Annual PHA Plan

The Agency Plan is a comprehensive guide to the Cordele Housing Authority's policies, programs, operations and strategies for meeting local housing needs and goals. There are two parts to the Plan: the Five-Year Plan, which the Authority submits to the Department of Housing and Urban Development (HUD) once every fifth fiscal year, and the Annual Plan, which is submitted to HUD every year. This document represents the Authority's FY2008 Agency Plan Annual Update.

Since the Agency Plan serves as the annual application for the Capital Fund Program (CFP), the Authority has submitted an Annual Statement and Five-Year Plan for the FY2008 CFP based on the actual funding allocation. The Annual Statement and Five-Year Plan can be found in this binder under Tab 2 (ga063a01).

The Authority scored a 75 on the most recent Public Housing Assessment System (PHAS) which results in a Standard Performer designation. The table below presents the scores for each of the four sections of PHAS.

The Authority is also continuing with the redevelopment of Sunset Homes. The Demolition Application for 36 units has been approved and the selected buildings have been demolished. The Authority will also be submitting another Demolition Application to remove 42 more units at Sunset Homes. More information about demolition is included in Section 8 of this document. Funds from the Capital Fund Financing Program (CFFP) will be used to build new units at Sunset Homes. The table below includes an action plan of the demolition process at Sunset Homes.

The Authority continues to work towards compliance with the Project-Based Management initiative launched by HUD. The Authority has selected four (4) property groupings, Sunset Homes (AMP-01), Morningside Homes (AMP-02), Scott/Shearer Homes (AMP-03), and Westside Homes (AMP-04). The Authority has developed budgets for these properties and the Central Office Cost Center. Revenues and expenses are being tracked by property to determine what, if any, actions need to be taken to make sure each property continues as a viable housing option.



Brief Statement of Progress in Meeting the 5-Year Plan Mission and Goals

Goal – Expand the Supply of Assisted Housing

The Capital Fund Program has been leveraged through the Capital Fund Financing Program to help fund the redevelopment of Sunset Homes.

Goal – Improve the Quality of Assisted Housing

As mentioned earlier, the PHAS score for FY2007 was a 75, which makes the Authority a Standard Performer. The score of the Financial Section brought the overall score down. The Authority will focus on this area in FY2008 with the hopes of raising the score and achieving High Performer status.

Resident satisfaction has improved to the point where only the Neighborhood Appearance section is below 75%. The scores received from the most recent survey are included in Attachment F.

The Authority continues to work toward renovating and modernizing the housing stock. This effort is funded through the Capital Fund Program. The budget for the FY2008 Capital Fund Program is included as an Attachment to the Agency Plan.

The Demolition Application for thirty-six (36) units at Sunset Homes has been approved and the Authority will be submitting another Demolition Application for forty-two (42) more units. The Authority will be providing replacement housing at this site.

Goal – Promote Self-Sufficiency and Asset Development of Families and Individuals

Resident Services continues to work toward resident awareness of opportunities to assist residents in becoming self-sufficient and improve resident satisfaction.

Through the Resident Opportunity and Self-sufficiency (ROSS) program, the Authority has targeted over 138 residents that are unemployed as well as needing to meet the community service requirements. We are working with residents to acquire their GEDs, development of employment skills, job training and other measures to improve their opportunity to become self-sufficient.

The Authority continues to provide financial fitness training, credit counseling and homeownership education to the residents. Teaching financial fitness, providing credit counseling educates our residents about the responsibilities homeownership. Our residents will be prepared as homeownership programs are development in our community.

Goal – Ensure Equal Opportunity in Housing for All Americans

The Authority continues to follow HUD regulations concerning admissions to and continued occupancy of public housing.

The survey asks residents questions about the Authority's performance in areas such as maintenance, communication, safety, services, and neighborhood appearance. Once the surveys have been completed and returned to HUD, the Authority receives a rating for each section. The Cordele Housing Authority received the following scores for the most recent survey which is for FY2007.

Neighborhood Appearance

GOAL: To improve the overall neighborhood appearance.

ACTION: Through demolition and Capital Fund Financing, the Authority will upgrade the housing stock to make it more attractive and livable for today's families.

Attachment G

Pet Policy

The Housing Authority of the City of Cordele allows pet ownership in its developments with written pre-approval of the Housing Authority. Residents are responsible for any damage caused by their pets, including the cost of fumigating and liability for the pet and agrees to hold the Housing Authority harmless from any claims caused by an action or inaction of the pet. This policy does not apply to animals that are used to assist persons with disabilities. The purpose of this attachment is to highlight some of the guidelines any resident must follow in owning a pet. The full policy is available at the Authority's main office.

The policy defines common household pets and how many pets a resident is allowed to keep on the premises.

Every pet must be registered with the Housing Authority's management prior to moving the pet into the unit and updated annually thereafter.

Every dog and cat must wear the appropriate local animal license, a valid rabies tag. All licenses and tags must remain current.

The policy states how each pet must be restrained when not in the owner's apartment.

Sanitary standards and waste disposal are discussed in the policy.

The policy states what happens when a pet violation occurs and how that violation is resolved.

A nonrefundable "Pet Fee" will be required for all pets. The "Pet Fee" must be paid in advance and is to be used to pay reasonable operational costs to the development. The amount of the pet fee is \$150.00.

Attachment H

Community Service Policy

As a condition of continued occupancy, excluding residents under Exemptions below, each adult resident of the Housing Authority shall:

- a. Contribute eight (8) hours per month of community service (not including political activities) within the community in which that adult resides; or,
- b. Participate in an economic self-sufficiency program for eight (8) hours per month.

Exemptions

Exemptions to the above requirement shall be made for any individual who:

- a. Is 62 years of age or older;
- b. Is a blind or disabled individual defined under section 216(i)(1) or 1614 of the Social Security Act (42 USC 416(i)(1); 1382c) and who is unable to comply with this section, or is a primary caretaker of such individual;
- c. Is engaged in a work activity (as such term is defined in section 407(d) of the Social Security Act (42 USC 607(d), as in effect on and after July 1, 1997)
- d. Meets the requirements for being exempted from having to engage in a work activity under the state program funded under part A of title IV of the Social Security Act (42 USC 601 et seq) or under any other welfare program of the state in which the public housing agency is located, including a state-administered welfare-to-work program; or,
- e. Is in a family receiving assistance under a state program funded under part A of title IV of the Social Security Act (42 USC 601 et seq) or under any other welfare program of the state in which public housing agency is located, including a state administered welfare-to-work program, and has not been found by the state or other administering entity to be in noncompliance with such program.

Annual Determinations

For each public housing resident, the Housing Authority shall, thirty (30) days before the expiration of each lease term of the resident, review and determine the compliance of the resident with the requirement. Such determinations shall be made in accordance with the principles of due process and on a nondiscriminatory basis.

Noncompliance

If the Housing Authority determines that a resident subject to the requirement is non-compliant, the Housing Authority shall notify the resident in writing of such noncompliance. The written notification shall state that the determination of noncompliance is subject to the administrative grievance procedure and that failure by the resident to enter into an agreement, before the expiration of the lease term, to cure any noncompliance by participating in an economic self-sufficiency program for, or contributing to community service, as many additional hours as the resident needs to comply in the aggregate with such requirement over the 12-month term of the lease, may be cause for lease termination.

The Housing Authority shall not renew or extend any lease, or provide any new lease, for a dwelling unit for any household that includes an adult member subject to the requirement who has been determined to be not compliant with the requirement and has failed to attempt to cure the noncompliance.

Attachment I

Information Concerning the Violence Against Women Act (VAWA)

The Cordele Housing Authority is striving to fully comply with all requirements of the Violence Against Women Act (VAWA).

First, the Authority will not deny admission to an applicant who has been a victim of domestic violence, dating violence, or stalking. The applicant must comply with all other admission requirements.

Also, the Authority will not terminate the assistance to a victim of domestic violence, dating violence, or stalking based solely on an incident or threat of such activity. The Authority still retains the right to terminate assistance for other criminal activity or good cause.

All information provided by an applicant or tenant regarding VAWA will be held in strict confidence and will not be shared with any other parties, unless required by law.

At this time, the Housing Authority does not intend to put a victim of domestic violence admissions preference in place. The Executive Director will periodically review the need for such preference and may add an admissions preference for victim of domestic violence if a need is determined.

To make sure all applicants are aware of the Violence Against Women Act, the Housing Authority notifies all applicants of the information included in the Act during the application process.
