## Attachment D

### **Brief Statement of Progress in Meeting 5-Year Plan Mission and Goals**

#### **PHA Goal: Improve the quality of assisted housing**

*a. Improve public housing management: (PHAS score)*

Improve public housing management: (PHAS Score). Our goal was to improve the management of the Nicholls Housing Authority and thereby improve the PHAS score. Although I believe we have improved the management of the Authority, this is not reflected in the PHAS score. We instituted a number of changes including a more comprehensive modernization program, a more thorough unit preparation program, an admissions and continued occupancy policy that is in line with Federal Regulations and a collection policy that tracks tenants who move out with an outstanding balance.

*b. Increase customer satisfaction.*

HUD was not able to issue a RASS survey for FY2007 so they rolled our score from the previous year to complete our PHAS score. Because of this, we do not have an accurate measurement of customer satisfaction for this year. Recent notifications indicate that the RASS survey is back on line so we may have an accurate indicator for FY2009.

*c. Renovate or modernize public housing units.*

We have completed Task I & II in our modernization program. These Tasks were designed to address the most pressing needs of our housing stock and to standardize all units. Our Risk Assessment will determine how much abatement is needed in future projects and will be addressed in Task III.

#### **PHA Goal: Provide an improved living environment**

*a. Implement public housing security improvements.*

The Nicholls Housing Authority has implemented HUD protocol for screening of applicants and has evicted those tenants who do not pay their rent or who violate HUD's One Strike Policy or other conditions of their lease.

b. The Alma Housing Authority maintenance staff continues to be responsible for prepping and maintaining units according to UPCS standards established by HUD.

#### **PHA Goal: Ensure equal opportunity and affirmatively further fair housing**

a. The Nicholls Housing Authority will continue to follow HUD guidelines in the admission and continued occupancy of its units.

b. All qualified candidates for housing will be placed on a waiting list that will be maintained by the Alma Housing Authority Occupancy Department.

HUD did not issue a RASS survey for FY2007. Because of contracting difficulties, they were unable to send the survey or get it scored. For our FY2007 PHAS score, HUD rolled forward our previous score. REAC indicates that the next RASS survey will start on 8/1/2009; so unfortunately, we do not have any resident feedback to evaluate at this time.
