Attachment A

Deconcentration Analysis

The Housing Authority will strive to create mixed-income communities and lessen the concentration of very-low income families within the Housing Authority's public housing developments through admissions policies designed to bring in higher income tenants into lower income developments and lower income tenants into higher income developments. This policy shall not be construed to impose or require any specific income or racial quotas for any public housing development owned by the Housing Authority.

The Swainsboro Housing Authority performed a review of all covered developments to determine if there are any that would be covered by the Deconcentration Rule. The results are as follows:

Attachment E

Criteria for Substantial Deviation and Significant Amendments

Substantial Deviation from the 5-year Plan:

A “Substantial Deviation” from the 5-Year Plan is an overall change in the direction of the Authority pertaining to the Authority’s Goals and Objectives. This includes changing the Authority’s Goals and Objectives.

Significant Amendment or Modification to the Annual Plan:

A “Significant Amendment or Modification” to the Annual Plan is a change in a policy or policies pertaining to the operation of the Authority. This includes the following:

- Changes to rent or admissions policies or organization of the waiting list.
- Additions of non-emergency work items over \$30,000 (items not included in the current Annual Statement or 5-Year Action Plan) or change in use of replacement reserve funds under the Capital Fund.
- Any change with regard to demolition or disposition, designation, homeownership programs or conversion activities.

Attachment F

Resident Assessment and Satisfaction Survey Follow-Up Plan

Overview

Due to contract negotiations, REAC has not been able to conduct resident surveys for the Housing Authority. REAC has made the decision to push the prior years RASS scores forward so that a final PHAS score could be issued. The scores below represent the Resident Assessment Survey scores for the fiscal year ending March 31, 2006.

As a result of this survey, the Housing Authority is required to develop a Follow-Up Plan to address each section score that fell below 75%.

The following includes the Follow-Up Plan for the Authority.

Communication

All information concerning lease, rules and regulations and other pertinent information is discussed with residents at time of application and lease-up. All forms are reviewed and explained. The Authority gives tenants copies of all forms for their records. It is explained to tenants that if any problems arise, they can call the office and the Housing Authority will work to resolve the problem.

Neighborhood Appearance

The Maintenance staff cleans up all yards and grounds each Friday. All trash is picked up and all large items that need to be removed are hauled to the county landfill by Housing Authority employees at SHA expense.

The Maintenance staff also cuts all grass on a regular basis.

Housing Authority staff also meets with the Resident Advisory Board on a regular basis to discuss any ideas for improvement in these areas.

Attachment G

Violence Against Women Act Information

The Swainsboro Housing Authority is striving to fully comply with all requirements of the Violence Against Women Act (VAWA) which pertain to public housing agencies. First, the Authority will not deny admission to an applicant based solely on the fact that they have been a victim of domestic violence, dating violence, or stalking. The applicant must comply with all other admission requirements.

Also, the Authority will not terminate the assistance to a victim of domestic violence, dating violence, or stalking based solely on an incident or threat of such activity. The Authority still retains the right to terminate assistance for other criminal activity or good cause.

All information provided by an applicant or tenant regarding VAWA will be held in strict confidence and will not be shared with any other parties, unless required by law.

At this time, the Housing Authority does not intend to put a victim of domestic violence admissions preference in place. The Executive Director will periodically review the need for such preference and may add an admissions preference for victim of domestic violence if a need is determined.

The Housing Authority notifies all applicants of the information pertaining to public housing agencies included in the Violence Against Women Act during the application process.
