## **Attachment D**

### **Statement of Progress Relating to the Five-Year Plan**

- The Authority has moved out of Troubled Status under the Public Housing Assessment Subsystem (PHAS) score, and is now considered a Standard Performer. The Authority continues to strive to be a High Performing PHA.
- Overall, residents seem to be satisfied with the service they receive from the Authority's staff. The staff has developed a Follow-Up Plan to address the low areas of the Resident Assessment and Satisfaction Survey. This Plan can be found in Attachment F.
- The Authority has recently completed a physical needs assessment on all properties. The assessment will be used to determine the use of the Capital Fund Program monies over the next few years.
- A demolition application for the fire damaged units at Shipp Street has been submitted to HUD. These units are an eyesore and will cost too much to renovate back to livability.
- On an on-going basis, staff members assess ideas to improve resident safety.
- The Authority continually works with outside agencies to provide supportive services to residents.
- The Authority strives to increase resident participation in outside programs.
- HUD guidelines continue to be followed concerning the admission to and occupancy of public housing.

### Deconcentration Analysis

The Canton Housing Authority performed a review of all covered developments to determine if there are any that would be covered by the Deconcentration Rule. The results are as follows:

Authority staff writes and distributes a newsletter on a regular basis. Items of interest of all residents are included in the newsletter.

#### **Neighborhood Appearance**

The Capital Fund Program will be used to modernize all sites within the next few years. A list of projected work items is included in the FY2007 CFP Annual Statement and Five-Year Plan section.

Residents are encouraged to participate in the Yard of the Month contest.

The Authority has contracted lawn maintenance and trash pick-up services out to a local contractor. Tenants are charged if the area around their unit is not kept litter free.

## **Attachment G**

### Violence Against Women Act Information

The Canton Housing Authority is striving to fully comply with all requirements of the Violence Against Women Act (VAWA). First, the Authority will not deny admission to an applicant who has been a victim of domestic violence, dating violence, or stalking. To be admitted to the program, the applicant must meet all other admission requirements.

Next, the Authority will not terminate assistance to a victim of domestic violence, dating violence, or stalking based solely on an incident or threat of such activity. The Authority still retains the right to terminate assistance for other criminal activity or good cause.

All information provided by an applicant or tenant regarding VAWA will be held in strict confidence and will not be shared with any other parties, unless required by law.

The Housing Authority's Admissions Policy already includes a victim of domestic violence admissions preference. This preference gives victims of domestic violence a priority over other applicants for available public housing units.

The Housing Authority provides all applicants with information regarding the Violence Against Women Act during the application process.
