

The PHA has included in the Plan submission a copy of the recommendations made by the Resident Advisory Board or Boards and a description of the manner in which the Plan addresses these recommendations.
4. The PHA made the proposed Plan and all information relevant to the public hearing available for public inspection at least 45 days before the hearing, published a notice that a hearing would be held and conducted a hearing to discuss the Plan and invited public comment.
5. The PHA will carry out the Plan in conformity with Title VI of the Civil Rights Act of 1964, the Fair Housing Act, section 504 of the Rehabilitation Act of 1973, and title II of the Americans with Disabilities Act of 1990.
6. The PHA will affirmatively further fair housing by examining their programs or proposed programs, identify any impediments to fair housing choice within those programs, address those impediments in a reasonable fashion in view of the resources available and work with local jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement and maintain records reflecting these analyses and actions.
7. For PHA Plan that includes a policy for site based waiting lists:
 - The PHA regularly submits required data to HUD's MTCS in an accurate, complete and timely manner (as specified in PIH Notice 99-2);
 - The system of site-based waiting lists provides for full disclosure to each applicant in the selection of the development in which to reside, including basic information about available sites; and an estimate of the period of time the applicant would likely have to wait to be admitted to units of different sizes and types at each site;
 - Adoption of site-based waiting list would not violate any court order or settlement agreement or be inconsistent with a pending complaint brought by HUD;
 - The PHA shall take reasonable measures to assure that such waiting list is consistent with affirmatively furthering fair housing;
 - The PHA provides for review of its site-based waiting list policy to determine if it is consistent with civil rights laws and certifications, as specified in 24 CFR part 903.7(c)(1).
8. The PHA will comply with the prohibitions against discrimination on the basis of age pursuant to the Age Discrimination Act of 1975.
9. The PHA will comply with the Architectural Barriers Act of 1968 and 24 CFR Part 41, Policies and Procedures for the Enforcement of Standards and Requirements for Accessibility by the Physically Handicapped.
10. The PHA will comply with the requirements of section 3 of the Housing and Urban Development Act of 1968, Employment Opportunities for Low-or Very-Low Income Persons, and with its implementing regulation at 24 CFR Part 135.
11. The PHA has submitted with the Plan a certification with regard to a drug free workplace required by 24 CFR Part 24, Subpart F.
12. The PHA has submitted with the Plan a certification with regard to compliance with restrictions on lobbying required by 24 CFR Part 87, together with disclosure forms if required by this Part, and with restrictions on payments to influence Federal Transactions, in accordance with the Byrd Amendment and implementing regulations at 49 CFR Part 24.

13. The PHA will comply with acquisition and relocation requirements of the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 and implementing regulations at 49 CFR Part 24 as applicable.
14. The PHA will take appropriate affirmative action to award contracts to minority and women's business enterprises under 24 CFR 5.105(a).
15. The PHA will provide HUD or the responsible entity any documentation that the Department needs to carry out its review under the National Environmental Policy Act and other related authorities in accordance with 24 CFR Part 58.
16. With respect to public housing the PHA will comply with Davis-Bacon or HUD determined wage rate requirements under section 12 of the United States Housing Act of 1937 and the Contract Work Hours and Safety Standards Act.
17. The PHA will keep records in accordance with 24 CFR 85.20 and facilitate an effective audit to determine compliance with program requirements.
18. The PHA will comply with the Lead-Based Paint Poisoning Prevention Act and 24 CFR Part 35.
19. The PHA will comply with the policies, guidelines, and requirements of OMB Circular No. A-87 (Cost Principles for State, Local and Indian Tribal Governments) and 24 CFR Part 85 (Administrative Requirements for Grants and Cooperative Agreements to State, Local and Federally Recognized Indian Tribal Governments.).
20. The PHA will undertake only activities and programs covered by the Plan in a manner consistent with its Plan and will utilize covered grant funds only for activities that are approvable under the regulations and included in its Plan.
21. All attachments to the Plan have been and will continue to be available at all times and all locations that the PHA Plan is available for public inspection. All required supporting documents have been made available for public inspection along with the Plan and additional requirements at the primary business office of the PHA and at all other times and locations identified by the PHA in its PHA Plan and will continue to be made available at least at the primary business office of the PHA.

Violence Against Women's Act of 2005 (VAWA)

It is the policy of the Municipal Housing Agency (MHA) to comply fully with the Violence Against Women's Act of 2005 as well as all other federal, state, and local laws governing violence against women. Under VAWA policy, the following are covered: children and adults who are victims of domestic violence, dating violence, sexual assault, or stalking. The purpose of this policy is to protect victims from being evicted or terminated from housing assistance based on acts of such violence against them. These provisions apply to all of the agency's public housing projects and the housing choice voucher program. Definitions are provided below:

- Domestic Violence: Includes felony or misdemeanor crimes of violence committed by a current or former spouse of the victim, by a person with whom the victim share a child in common, by a person who is cohabitated with or has cohabited with the victim as a spouse, by a person similarly situated to a spouse of the victim under the domestic or family violence laws of the jurisdiction receiving federal funding, or by an other person against an adult or youth victim who is protected from that person's acts under the domestic or family violence laws of the jurisdiction.
- Dating Violence: Violence committed by a person:
 - A. Who is or has been in a social relationship of a romantic or intimate nature with the victim; and
 - B. Where the existence of such a relationship shall be determined based on a consideration of the following factors: (i) the length of the relationship; (ii) the type of relationship; and (iii) the frequency of interaction between the persons involved in the relationship.
- Stalking: To follow, pursue, or repeatedly commit acts with the intent to kill, injure, harass, or intimidate; or to place under surveillance with the intent to kill, injure, harass, or intimidate another person; and in the course of, or as a result of, such following, pursuit, surveillance, or repeatedly committed acts, to place a person in reasonable fear of the death of, or serious bodily injury to, or to cause substantial emotional harm to (i) that person; (ii) a member of the immediate family of that person; or (iii) the spouse or intimate partner of that person.
 - Immediate Family Member: An established domestic partner, spouse, parent, brother or sister, or child of the person, or an individual to whom that person stands in loco parentis (in place of a parent); or any other person living in the household of that person and related to that person by blood, marriage or legal guardianship.

Admissions and Screening

The Public Housing and Housing Choice Voucher Programs application process makes inquiry to identify if an applicant is experiencing domestic violence, dating violence, or stalking. If the applicant is experiencing any of the above, referrals are provided to applicants to our partnering organizations.

Non-Denial of Assistance: MHA will not deny admission to public housing or to the Housing Choice Voucher Program to any person because that person is or has been a victim of domestic violence, dating violence, or stalking, provided that such person is otherwise qualified for such admission.

Mitigation of Disqualifying Information: When assisted is requested whose history include incidents in which the applicant was a victim of domestic violence, MHA will take such information into account in mitigation of potentially disqualifying information, such as poor credit history or previous damage to a dwelling. If requested by an applicant to take such mitigating information in account or that preference points be given, MHA shall require applicants to provide police reports, protection orders, and written documents from a licensed therapist, counselor, etc. HUD Form 50066 “Certification of Domestic Violence, Dating Violence or Stalking” will also be filled out by the applicant. For additional information on what is required to verify the claimed history of domestic violence, please refer to the Section 8 Administrative Plan.

Program Participants and Re-certification

Upon yearly Re-certification, MHA makes inquiry to identify if an applicant is experiencing domestic violence, dating violence, or stalking. If the participant is experience domestic violence, referrals are provided to participants to our partnering organizations.

VAWA Protections: Under VAWA, public housing residents and housing choice voucher recipients have the following specific protections, which will be observed by MHA:

1. An incident or incidents of actual or threatened domestic violence, dating violence, or stalking will not be considered to be a “serious or repeated” violation of the lease by the victim or threatened victim of that violence and will not be good cause for terminating the tenancy or occupancy rights of or assistance to the victim of that violence.
2. In addition to the foregoing, tenancy or assistance will not be terminated by MHA as a result of criminal activity, if that criminal activity is directly related to domestic violence, dating violence or stalking engaged in by a member of the assisted household, a guest or another person under the tenant’s control, and the tenant or an immediate family member is the victim or threatened victim or this criminal activity.

Removal of Perpetrator: Public Housing residents and Housing Choice Voucher recipients who are guilty of violating VAWA shall be removed without regard to whether a household member is a signatory to the lease, in order to evict, remove, terminate occupancy rights, or terminate assistance to any individual who is a tenant or lawful occupant and who engages in acts of physical violence against family members or others.

Agency Services & Partnerships

It is the policy of MHA to cooperate with organizations and entities, both private and governmental, which provide shelter and/or services to victims of domestic violence. MHA provides domestic abuse information on all public bulletin boards at the Section 8 office and both public housing projects. If MHA staff becomes aware that an individual assisted by MHA is a victim of domestic violence, dating violence, or stalking, MHA will refer the victim to such providers of shelter or services as appropriate.

Municipal Housing Agency partners with the following organizations to provide services to children and adults who are victims of abuse:

1. Catholic Charities: The Phoenix Housing Domestic Violence Shelter
 - i. The shelter provides safe, confidential living, a 24-hour crisis phone line, support groups, educational classes, and provides advocacy and support for medical and legal issues.
2. Catholic Charities: Counseling Services
 - i. The counseling program provides counseling services to individuals, couples, and families with a focus on trauma, abuse, and family violence. This service offers financial assistance through the Interfaith Response Organization.
3. Heartland Family Service
 - i. Family Services offers emergency services for victims of domestic abuse and their children including shelter, clothing, meals, financial assistance, transportation, medical assistance, a 24-hour crisis line, educational services, and support groups for victims of domestic violence.
